Board Renewal Period November 1—December 31, 2023

- Complete all renewal requirements through the licensee <u>Self-Service Portal</u> between November 1- <u>Dec. 31, 2023 by 11:59pm.</u>
 - * Renewal application & fee
 - Proof of completion of 32 hours of approved CE earned in calendar year 2023. Including the following required education for all active licensees:
 - Pain Management—One (1) credit hour every odd number calendar year
 - Medical Ethics or Suicide Intervention and Prevention— Two (2) total hours
 - * Pharmacology— Ten (10) total hour


DO WE HAVE YOUR DEA DIGITS?

Licensees with a DEA number need to enter their number in the self service portal as part of their contact information.

ARE YOU REGISTERED WITH PDMP?

All prescribers in the State of Oregon are require to register with PDMP

CE completion certificates must be submitted individually as a PDF.

Each CE activity must be AP-PROVED to be accepted in the portal.

CE applications for approval submitted AFTER Nov 15 will not be approved by the deadline for renewal.

Oregon Psilocybin Services (OPS) -Oregon Health Authority

Oregon Psilocybin Services (OPS) is a new section housed within the Oregon Health Authority Public Health Division's Center for Health Protection. The Board does not regulate any aspect of psilocybin services or facilitator licensure. **OHA has complete jurisdiction over the program.** OBNM has not imposed any additional administrative rules or requirements for licensed Oregon NDs participating in Oregon Psilocybin Services.

Please monitor the *OHA website* for training, licensure requirements, and regulations related to psilocybin services including and not limited to:

- ORS 333-333-5130 (3) states, "If a facilitator holds a professional license in another field, the facilitator shall not exercise the privileges of that license while providing psilocybin services to clients", thus licensed naturopaths should understand and make it clear to their patients that they make not act under their ND scope of practice while in the role of psilocybin facilitator
- Holders of DEA licenses should understand that psilocybin remains a federal Schedule I substance and the DEA has not offered a statement on enforcement of their rules in states that have state-legal programs. License holders should consult with their lawyers to better understand their risk.



Oregon Licensees may prescribe all drugs and drugs within a drug classification on the AHFS - unless specifically excluded by rule. Some drugs may not be specifically listed by brand name because they are listed under their generic name or have recently been approved. If you can not find the drug by name, search the AHFS by category to determine whether you are permitted to prescribe. Please contact the Board for the password to access the searchable AHFS on the website by either drug name or category.

Oregon Administrative Rule Changes-Process & Public Comment

The Board has the authority to engage in rulemaking to amend, repeal or adopt Oregon Administrative Rules. The Board is required to notify the public of a proposed rule and provide a public comment period of no less than 28 days.

The Board posts all draft rules for public <u>comment on the website</u>. Please check the site regularly and send in your public comment!

The Board must vote in public session to adopt the proposed rule as a permanent rule. Licensees and the public are welcome to attend all public board meetings.



DIRECTOR'S REPORT:

Board staff spent the majority of the year working with the legislature during the bi-annual session. The legislature requires the Board maintain a sixmonth income reserve in the budget. For legisla-



month income reserve in the budget. For legislative approval of the budget, the Board had to raise licensure fees and impose new application processing fees. Please know the need to raise fees to maintain the reserve was out of the Board control and due to legislative mandates that significantly impacted the Board budget, as well as inflation and rising costs of goods and services.

Unfortunately, because the legislature was inundated with an exceptionally high number of bills, the Board's two legislative concepts did not move forward this session.

The Board is looking to make several changes to Oregon Administrative Rules in 2024 to enhance transparency and accountability and fulfill our commitment to public safety and excellent service to Oregonians and licensees.
