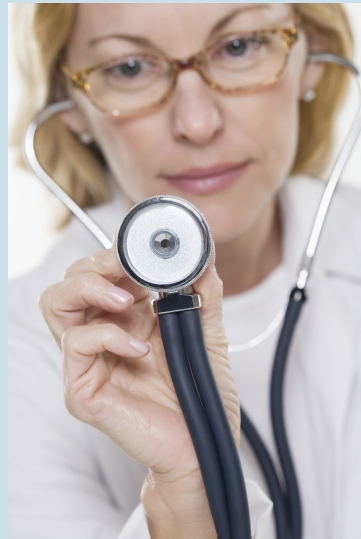

A Quick Word About CE Requirements

Continuing Education (CE) is required as part of the naturopathic physician's license renewal, per OAR 850-030-0195. The purpose of CE is to offer education that promotes competence and skills necessary to assure the citizens of Oregon the highest standard of naturopathic medical care.



All licensees must complete the required number of CE hours to renew their license. You will not be able to renew your license if you do not complete the required CE.

Please bear in mind that CE hours obtained and approved are applied to the year in which they were obtained/ approved. One exception is that hours obtained in December, and not used in the year obtained, may be credited the following year.

Also, page 2 of this newsletter contains some helpful continuing education frequently asked questions.

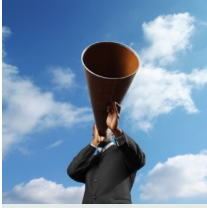

CE FAQ's



How many hours of CE does a ND have to complete?

Per OAR 850-040-0210:

(a) *Each licensee with an **active** license must obtain at least 25 hours in CE every year, with at least five of these hours in*

pharmacy;

(b) *Each license holding an **inactive** license must obtain at least 10 hours of CE every year.*

(c) *A natural **childbirth certificate** requires 15 hours in obstetrics each year per OAR 850-035-0230.*

(d) ***New licensees** are not require to obtain CE in the initial year of licensure.*

Where can I obtain CE hours?

There are many places to obtain CE hours. A quick reference for CE is to visit the OBNE website and view a list of currently approved CEs and Professional Development Providers (PDP). You can also reference some online options via the OBNE website.

Can I do all my CE hours via on-line?

NO. If you live and practice in Oregon*, you must have a least 10 hours of CE from actual physical attendance of a program; per OAR 850-040-0210(2)(b).

* Per OAR 850-040-0210(8)(a) *Licensee maintaining an active license in Oregon but not living and practicing in Oregon may obtain up to 20 hours of CE by nonattendance activities that satisfy the program qualification in OAR 850-040-0210*

How do I know if the program I want to attend will count as CE hours?

You can visit the OBNE website for a list of currently approved CEs and PDPs. If your program is not listed and you are unsure it meets the requirements in OAR 850-040-0210, you will need to submit an application for CE approval. You can find this form and the guidelines for completing the form on our website.

I'm confused about the pain management, ethics and pharmacy requirements.

Pain: All licensees are required to obtain seven (7) hours of pain management education. This is a mandatory one-time CE requirement. There is a required one (1) hour session to be completed online. You can find this session by visiting the OBNE website, under the Continuing Education tab.

Ethics: All licensees are required to obtain three (3) hours of medical ethics every three (3) years.

Pharmacy: Licensees are required to obtain at least five (5) hours pharmacy education every year.

Are acupuncture programs acceptable for CE hours?

NO. Acupuncture requires separate licensing under a different board. In addition, acupuncture is not within the scope of practice for NDs. For these reasons acupuncture programs are not suitable CE for NDs.

What if I do not complete the required CE hours?

If the CE is not obtained by December 31st, your license will expire for non-compliance and you will not be allowed to practice until your license is restored to good standing.

I have been/will be unable to fulfill my CE, can I get an extension and/or not have to complete the required CE?

MAYBE. Per ORS 685.102(2) *The Board may exempt any person holding license under this chapter from the requirements of subsection (1) of this section upon application showing evidence satisfactory to the Board of inability to comply with the requirements because of physical or mental condition or because of other unusual or extenuating circumstances.*

Please contact the Board directly if you feel you meet the requirements for exemption.

I did more than 25 hours of CE, can I use the extra CE hours for next year?

NO. Per OAR 850-040-0210(1)(C) *Credit for this required education will be given in the year education is obtained.*

As an exception, hours obtained in December, and not used in the year obtained, may be credited in the following year.

Do I have to send all my course completion certificates to OBNE?

NO. Please keep these for your records and in case of an audit. You should keep these on file for a period of at least five (5) years.

HELPFUL HINTS FOR CE APPLICATION SUBMISSION

Remember to include the following with your CE Application:

- ◆ A time-base schedule of activity
- ◆ Presenter Qualifications
- ◆ Orientation. CE programs must be professional level programs, directed to healthcare professionals and related to naturopathic medicine.

For specialty credit (pharmacy, OB, ethics) please be specific and show a detailed time line devoted to each topic (s).

Why does the Board need your address and contact information?

- ◆ So you can receive important and informational Board mailings.
- ◆ So you can receive information on proposed rule changes and have the ability to provide your input.
- ◆ So the Board can contact you if a complaint is filed against you or against another licensee and you may be a witness.
- ◆ So you can receive your license renewal form.
- ◆ OAR 850-050-0130 requires licensees to notify the Board in writing within 30 days of any change of residence, practice and/or mailing address.

2009-2011 Legislative Concepts

The Board has submitted three Legislative Concepts (LC) for consideration in the 2009-2011 Legislative session, which will begin January 1, 2009. These Legislative Concepts are as follows:

LC466 – It is time the name of the Board reflect the true purpose of the Board. The Board licenses and regulates the practice of Naturopathic Medicine. The NPLEX exams are now administered by the North American Board of Naturopathic Examiners (NABNE) and has been since 2000.

LC467 – The task of the Formulary Council (FC) is to make sure that licensees have access to all substances that are available for patient care, which fall within the guidelines of ORS 685.145. The list of substances on the formulary compendium continues to grow well past 300 items and still some of the patient management tools found in prescription drugs are not available to NDs.

LC468 – This concept is house keeping only. The civil penalties in ORS 685.110 and 685.990 are not consistent; this amendment will clarify that the civil penalty is “up to \$5,000 per violation”. In ORS 685.125 the language which gives the board authority to write rules as necessary is archaic; the language will be clarified.

Once draft language has been obtained by this office, we will post the proposed language to the OBNE web site for your consideration (www.obne.state.or.us). You can request a copy of these amendments through the board office if you do not have access to the internet.

I dedicate myself to the service of humanity as a practitioner of the art and science of Naturopathic medicine.

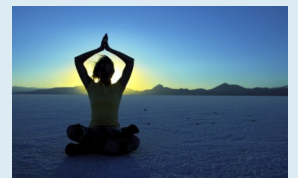

License Renewal Update and Reminders

In an effort to create a quicker and more seamless renewal process, OBNE is working on an online renewal system to begin this year. More to come later...

Also beginning this year, license renewals will be an annual renewal with the following renewal fees:

- ◆ \$275 for an active license
- ◆ \$125 for an inactive license
- ◆ \$15 for a retired license
- ◆ \$60 for a certificate of special competency in natural childbirth



A completed renewal application will consist of the following items:

- ◆ Completed renewal form
- ◆ License fee
- ◆ Completed affidavit confirming completion of CE
- ◆ Late fee, if applicable

By October 20th, the Board will send all licensees a renewal form via email to the last email address on record, *so be sure we have your current email address*. If you do not use email, you will be mailed a paper renewal by November 1st, *so be sure we have your current mailing address*. If you have not received your renewal form by November 15th, you will need to contact the OBNE office. OBNE will not be responsible for undeliverable mailings.

If you fail to submit a completed renewal by December 15th, you will need to submit the \$75 late fee and completed renewal by December 31st. If this deadline is not met, your license will lapse and you will not be able to practice until your license is brought back to good standing, which includes a \$150 restoration fee.

For more information regarding licensure, please review OAR Chapter 850, Division 30.

Using the terms "specialty" or "specialize"

685.110 Grounds for discipline; penalties... (22) *Representing that the licensee is a medical specialist or practices a medical specialty.*

This language, which was added to our statute in 1989, is meant to prevent licensees from presenting to be osteopathic or other specialists in the field of allopathic medicine.

Licensees may not advertise to be a medical specialist or practice in a medical specialty, except when certified as natural childbirth providers. Although these terms may not be used, by law, to represent that a licensee has extended training or a greater interest in the care of patients in a specific area of practice, it does not prevent a licensee from advertising these areas of "greater interest", "expertise", or "extended training" or "experience" in an area of practice.

With all the professional level education available to licensees, it seems there should be an allowance for the advanced education and training education to be clearly presented as a specialty in advertising; however, as the law is written licensees may not use the term "specialty" or "specialist" in advertising unless holding a certificate in natural childbirth.
