## **Acting Director's report**

Acting Director Henderson introduced Geoff Huntington, Senior Natural Resources Advisor, Office of the Governor. Mr. Huntington joined the meeting to promote good governance and looks forward to being a partner with the Board and agency to be a connection to the Governor's office. Looking to support good inter-agency communication and working together. He looks forward to meeting with the board again at a future meeting.

Acting Director Henderson reported things are going well in the agency and is very proud of the ODA team. He spoke about the agencies commitment to customer service and encouraged board members if they are hearing any concerns or issues to please reach out to him.

## Agenda Item 02 - ODA's Budget and Legislative Update

Assistant Director Jonathan Sandau shared with the board the agency is currently tracking about 2500 bills introduced this legislative session. HB 2289 relating to the percentage of ethanol required in gasoline sold in the state could be the first bill through both chambers. Sandau commented the next Revenue forecast is out today and is about \$503 million above the December forecast. The Governor's budget was released on January 31. A summary of the ODA's 23-25 Governor's Recommended Budget Summary was shared and reviewed with the Board.

# Agenda Item 05 - ODA Plant Protection & Conservation Program Updates

Chris Benemann, ODA Plant Protection & Conservation Program Director and her management team of Alan Hanson, Cody Holthouse, and Troy Abercrombie gave an overview of the Plant Program Area programs. This is a relatively new management team to the Program with Chris in the Program Director role since November 2020, Alan since May 2022, Cody joined ODA in August 2022 and Troy joining the management team this month. This team manages the Industrial Hemp, Insect Pest Prevention & Management Program, Native Plant, Noxious Weeds and Nursery programs. Ms. Benemann represents the ODA on the National Plant Board as well as the Oregon Invasive Species Council. Each area spoke to the size of the programs, recent accomplishments, and challenges.

# Agenda Item 06 - Introduction to the CAFO Permitting Process

Wym Matthews, ODA Fertilizer and CAFO Program Manager and Zach Loboy, DEQ Watersheds & Stormwater Manager introduced the CAFO permitting process. They discussed the definition of a CAFO as defined in Oregon Administrative Rule (OAR) 603-074-0010(3) and the long history between the Oregon Department of Agriculture and the Department of Environmental Quality to oversee the CAFO Program. The presentation also reviewed the roles and responsibilities of each agency. Mr. Matthews talked about the ODA CAFO Permit compliance and inspection activities and the number and types of CAFOs currently permitted in Oregon. He also highlighted the neighboring states CAFO permitting requirements.
