Approval of minutes

Acting Director’s report

Acting Director Henderson reported the ODA is beginning to implement the 23-25 Legislatively adopted budget. The agency budget has limited changes from last biennium. The current budget needs to go through the audit process before it is finalized. The ODA laboratories moving to the North Valley Complex in Wilsonville are on track to move sometime between October and January. The agency has been working with the cherry industry regarding a disaster declaration with the Governor’s office and USDA. Acting Director Henderson and Assistant Director Sandau will be attending the NASDA annual meeting in Wyoming next month. Acting Director Henderson expressed appreciation for the board members and their commitment to serve on the board.

Agenda Item 02 – ODA Project Overview

Henderson and Sandau shared with the board two projects underway at the agency. The 2018-2023 Agency Strategic Plan is due for review and updating. This is also part of the Governor’s initiatives for state agencies to ensure each state agency has a plan. The current agency DEI work and strategic plan will be embedded in the updated agency plan moving forward. Copies of the 2018-2023 summary and plan were provided to the board for reference. The updated plan is due June 1, 2024.

The ODA has been allocated approximately \$5.9 million as part of the USDA Resilient Food Systems Infrastructure Grant Program. The agency is in the process of submitting an outline of a state plan as required by USDA and will be working to collect input from industry partners on the priorities for the grant program in Oregon. A survey is underway to collect input and will be shared with the board members for input and to assist with the distribution of the survey. The agency will need to request federal funds limitation prior to spending. The grant program is expected to open in January 2024.

Agenda Item 06 – Inter-agency Project to Update Oregon’s Integrated Water Resources Strategy (IWRS)

Crystal Grinnell, IWRS Specialist with the Oregon Water Resources Department updated the board on the inter-agency project to update Oregon’s Integrated Water Resources Strategy. The IWRS is used to provide high-level descriptions of water issues and proposed solutions, information about agency programs, agencies and stakeholders references recommended actions to support funding or policy requests and supports agency work plans. The IWRS team has collected public input to the plan and is currently drafting an updated IWRS plan which will have public review this fall and a final report will be completed in early 2024.

Agenda Item 07 – Introduction to Clean Fuels Program and Renewable Fuel Standards in Oregon

Steven Harrington, Program Manager for the ODA Weights & Measures Motor Fuel Quality Program and Cory-Ann Wind, Oregon Clean Fuels Program Manager for DEQ spoke to the board regarding the clean fuels program and renewable fuel standards. The goal of the Clean Fuels Program is to reduce carbon emissions, greenhouse gas emissions from Oregon’s transportation fuels. Transportation sources make up about 40% of the emissions for the entire state. The program focusses on removing and reducing the greenhouse gas emissions from those fuels. Steven Harrington provide the board with information on the significant legislation implementing the Renewable Fuels Standards in Oregon.

Agenda Item 08 – OSU College of Agricultural Sciences – Dean’s Update

Dean Simonich shared with the board the OSU College of Agricultural Sciences expects enrollment to be up about 3% this fall. The college broke a record this year in terms of research expenditures at \$114 million. Research expenditures doubled within the College in the past two years. The OSU board of trustees now has three members Karla Chambers, Grant Kitamura, and Greg MacPherson with an agricultural background. This is good news. They are in the process of searching for branch extension station directors in Astoria and the Food Innovation Center in Portland. They hope to announce appointments in Hood River, Madras and at the Oregon Wine Research Institute very soon. The Legislative outcome for the college was good this year. Extension and the College all received continuing service levels in the budget. The College received \$10 million for resilient food systems and the resilient Oregon package.

Agenda Item 09 – Tillamook Working Lands & Water Cooperative

The group formed in 2016 in Tillamook to increase awareness of working forests, farms and fishers and the importance of providing sustainable, locally grown, and harvested products. Volunteers from farming, fishing and the forest sector help guide the organization. The group participates in many local activities and provides “It’s About the Water” tours for legislators and community leaders. Lead organizers from the group Carol Marie Leuthold and Pam Zweifel share their farm stories, Dave Kunert talked about the forests and Ray Monroe spoke about the fisheries in the area. They are committed to the responsible stewardship of Tillamook County’s natural resources and to sustain the community for generations to come.
