



Oregon State Situation Report

2024 HPAI OUTBREAK

Current as of April 1, 2024

Since the last situation report on March 18, 2024, there have been **0 additional positive premises in Oregon.**

PREMISES QUARANTINES

Confirmed positive premises are quarantined for a minimum of 120 days on average, although shorter quarantines may be utilized depending on the Cleaning and Disinfection (C&D) methods applicable to the premises.

ACTIVE REGIONAL QUARANTINES (CONTROL ZONES)

Established for World Organization for Animal Health (WOAH) designated poultry premises. Regional quarantines extend a minimum 10 km around an infected premises with movement restrictions on poultry and poultry product. Regional quarantines involve permitted movements and active surveillance for the designated area.

SURVEILLANCE ZONES

A 10km zone around an infected premises that collected data on nearby poultry premises and numbers. Surveillance zones are either active, where response staff reach out for information, for WOAH designated poultry premises, or passive, where information is self-reported by producers, for non-poultry WOAH designated premises.

Situation Summary (New information is in red)

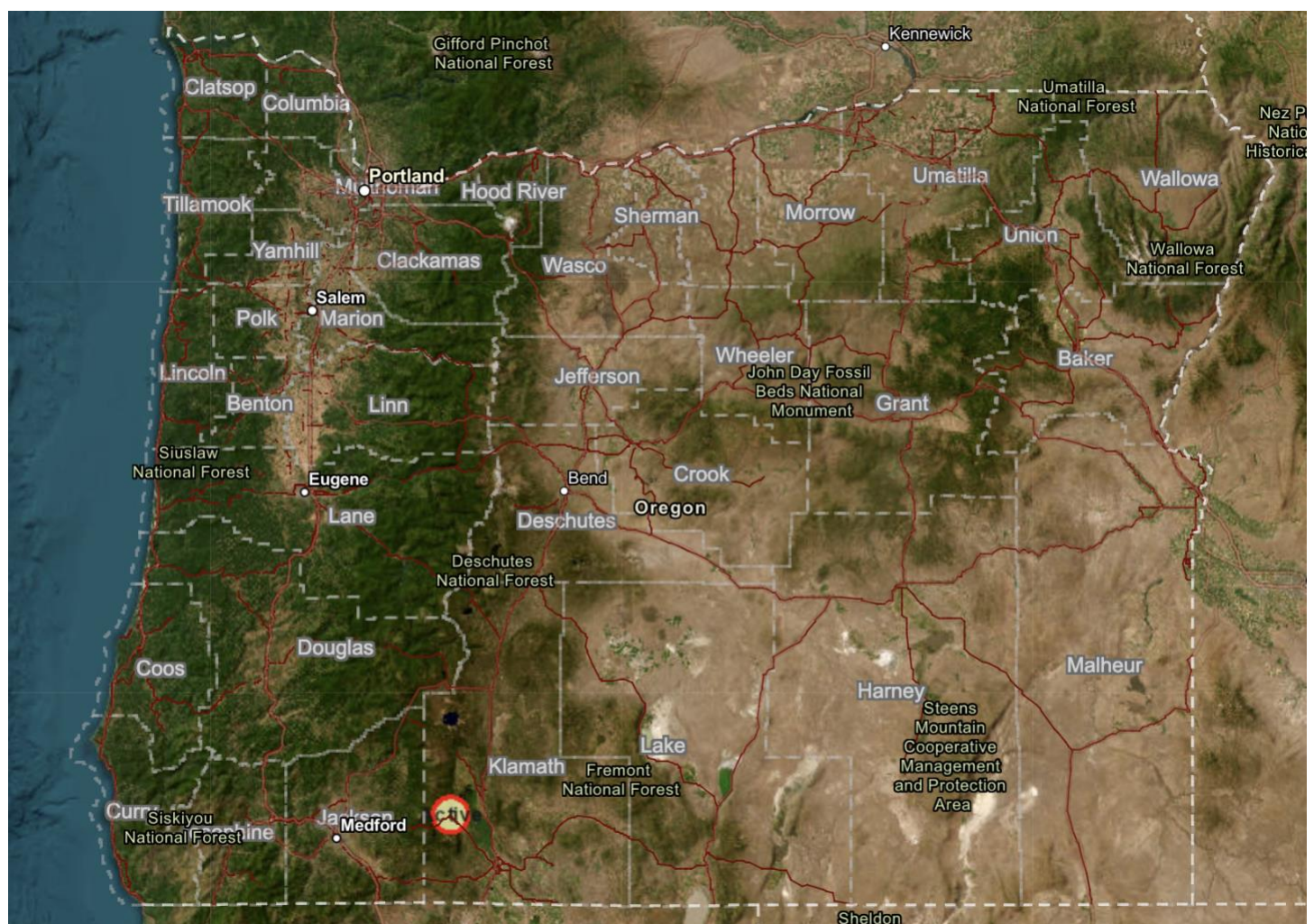
On October 20th, 2023, a premises in Union County tested positive for highly pathogenic avian influenza (HPAI). The premises was quarantined, and a regional quarantine was established on October 20, 2023 (OAR 603-011-5004). On October 23rd, 2023, a second case in Union County was confirmed positive. The premises was quarantined on October 20th, 2023. On November 8th, 2023, a premises in Deschutes County tested positive for HPAI. The premises was quarantined on November 4th and a surveillance zone was created. On November 8, 2023, a premises in Marion County tested positive for HPAI. A surveillance zone was created on November 9th and the premises was quarantined on November 14th. On November 13, 2023, a case of HPAI was confirmed in Linn County. The premises was quarantined on November 13th and a regional quarantine was issued on November 17th for this case. On November 14, 2023, the regional quarantine and surveillance zone in Union County were released. On November 14, 2023, a second case of HPAI was confirmed in Marion County. The premises was quarantined on November 14th and a regional quarantine was issued on November 17th for this case. On November 27th, 2023 a case of HPAI was confirmed in Clackamas County. The premises was quarantined on November 22nd. A surveillance zone for Clackamas County was established on November 27th, 2023. The surveillance zone for Marion County was released on November 27th, and the surveillance zone for Deschutes County was released on November 29th. The regional quarantine for Marion County was released on December 8th, 2023. The surveillance zone for Clackamas County was released December 11th, 2023. On December 12, 2023 a case of HPAI was confirmed in Clatsop County. The premises was quarantined on December 10, 2023 and a surveillance zone was established December 14, 2023. On December 18, 2023 a case of HPAI was presumptive positive in Benton County. The property was quarantined on December 16, and a surveillance zone was established on December 20, 2023. On December 28, 2023 the surveillance zone for Clatsop County was released. On December 28, 2023 the regional quarantine for Linn County was released. On January 5, 2024 the surveillance zone for Benton County was released. On February 20, 2024 two premises quarantines in Union County were released. On March 4, 2024, the premises quarantine in Deschutes County was released. On March 11, 2024, a premises in Klamath County was presumptive positive for HPAI. The premises was quarantined on March 8, 2024. **On March 4, 2024, the premises quarantine for Marion County was releases.**

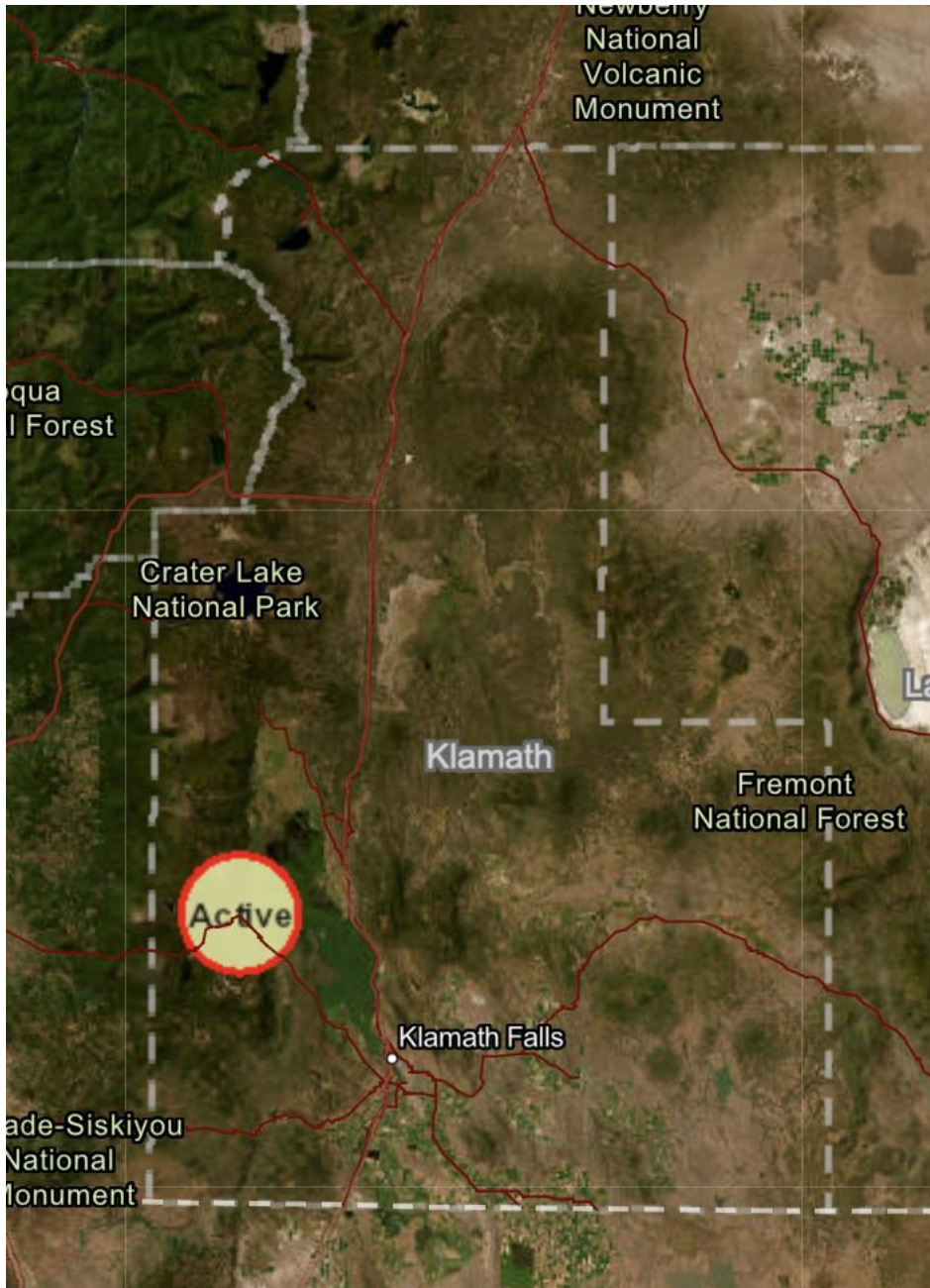
Map 1

Active Cases in Oregon



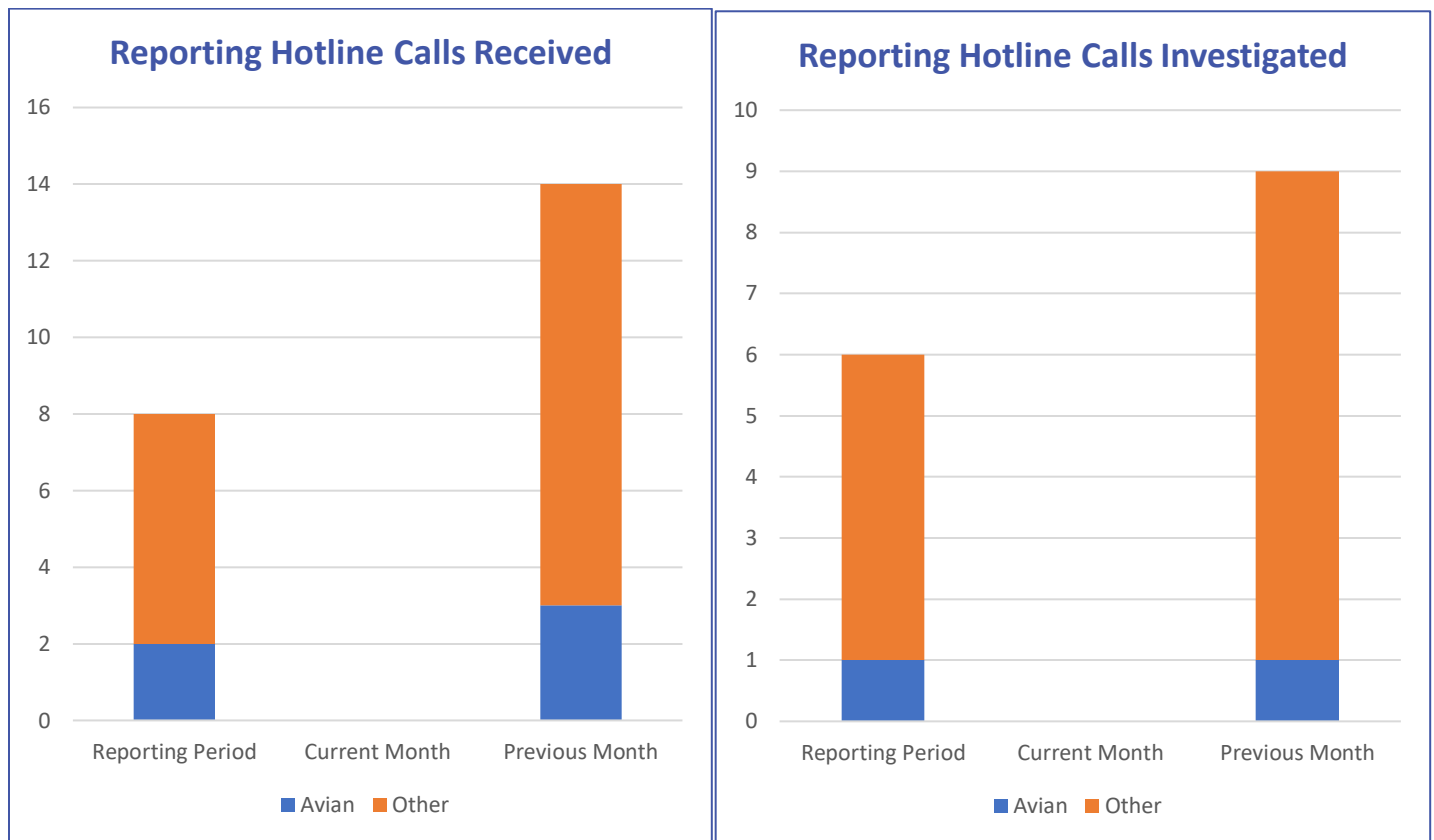
Map 2
