



# Oregon State Situation Report

## 2024 HPAI OUTBREAK

Current as of December 10, 2024

Since December 2, 2024, there have been 1 **additional positive premises in Oregon.**

### **PREMISES QUARANTINES**

Confirmed positive premises are quarantined for a minimum of 120 days on average, although shorter quarantines may be utilized depending on the Cleaning and Disinfection (C&D) methods applicable to the premises.

### **ACTIVE REGIONAL QUARANTINES (CONTROL ZONES)**

Established for World Organization for Animal Health (WOAH) designated poultry premises. Regional quarantines extend a minimum 10 km around an infected premises with movement restrictions on poultry and poultry product. Regional quarantines involve permitted movements and active surveillance for the designated area.

### **SURVEILLANCE ZONES**

A 10km to 20 km zone around an infected premises that collected data on nearby poultry premises and numbers. Surveillance zones are either active, where response staff reach out for information, for WOAH designated poultry premises, or passive, where information is self-reported by producers, for non-poultry WOAH designated premises.

## **Situation Summary** (New information is in red)

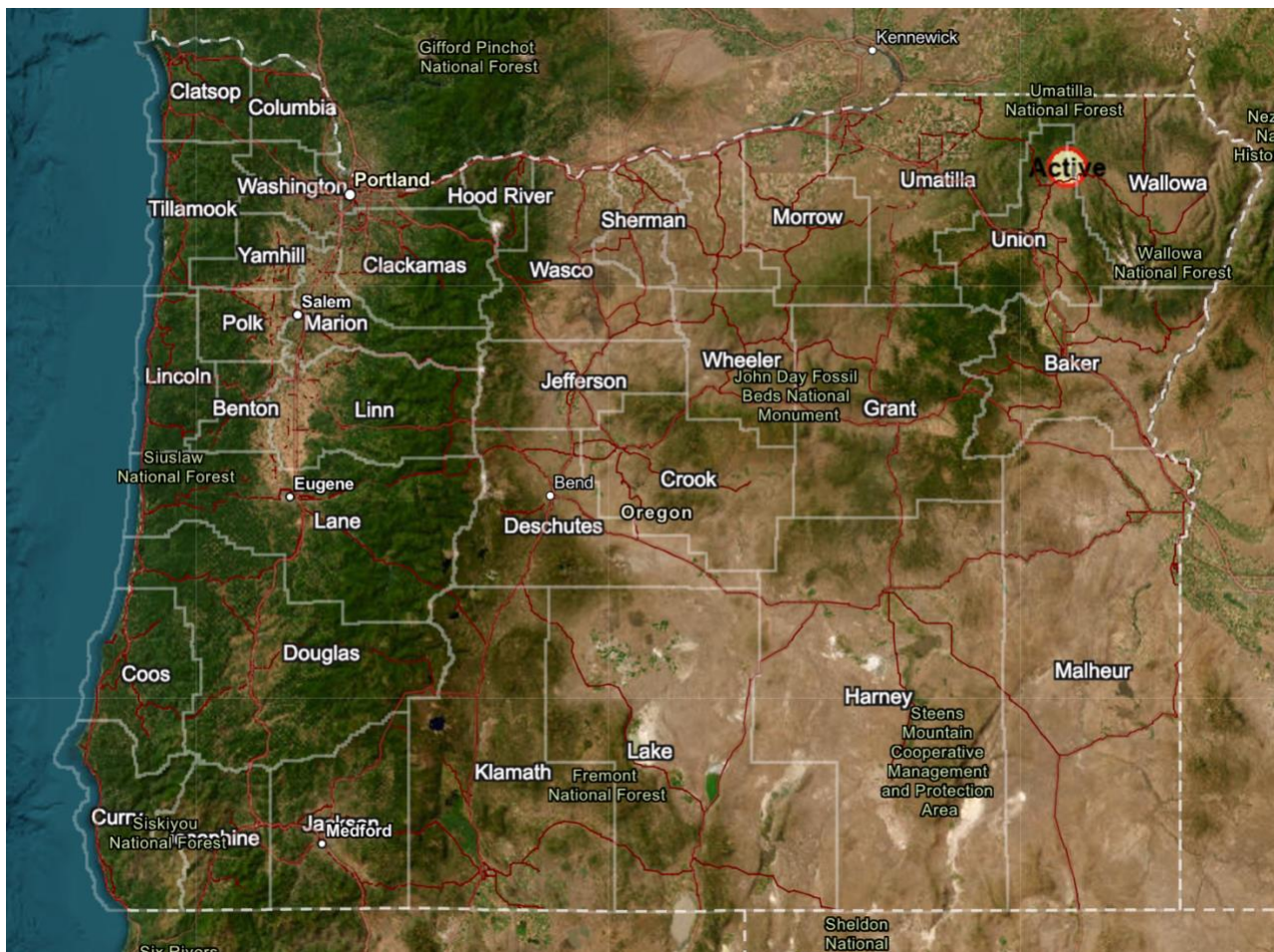
On October 21<sup>st</sup>, 2024, a case of HPAI was presumptive positive for Clackamas County and premises quarantine was issued. On October 22<sup>nd</sup>, 2024, a premises quarantine was issued for Crook County. On October 23<sup>rd</sup>, 2024, HPAI was confirmed positive for Clackamas County, a regional quarantine was issued for Clackamas County and HPAI was presumptive positive for Crook County. On October 25<sup>th</sup>, 2024, HPAI was confirmed positive for Crook County and a surveillance zone was issued. On October 29<sup>th</sup>, 2024, HPAI was presumptive positive in Swine for Crook County. On October 30<sup>th</sup>, 2024, HPAI was presumptive positive for Jackson County and a premises quarantine was issued. On November 1<sup>st</sup>, 2024, HPAI in swine was confirmed positive in Crook County, HPAI was confirmed positive in Jackson County and a surveillance zone was issued for Jackson County. On November 7<sup>th</sup>, 2024, a premises quarantine was issued for Malheur County. On November 8<sup>th</sup>, 2024, a case of HPAI was presumptive positive for Malheur County and the surveillance zone for Crook County was released. On November 13<sup>th</sup>, 2024, HPAI was confirmed positive in Malheur County and a surveillance zone was issued. On November 15<sup>th</sup>, 2024, the surveillance zone for Jackson County was released. On November 18<sup>th</sup>, 2024, a premises quarantine for Union County was issued. On November 22<sup>nd</sup>, 2024, a case of HPAI was presumptive positive for Union County. One November 27<sup>th</sup>, 2024, the surveillance zone for Malheur County was released. On November 27<sup>th</sup>, 2024, a surveillance zone for Union County was issued. On November 29<sup>th</sup>, 2024, the regional quarantine for Clackamas County was released. **On December 5<sup>th</sup>, 2024, HPAI was presumptive positive in Deschutes County and a premises quarantine was issued.**

### Active Cases in Oregon



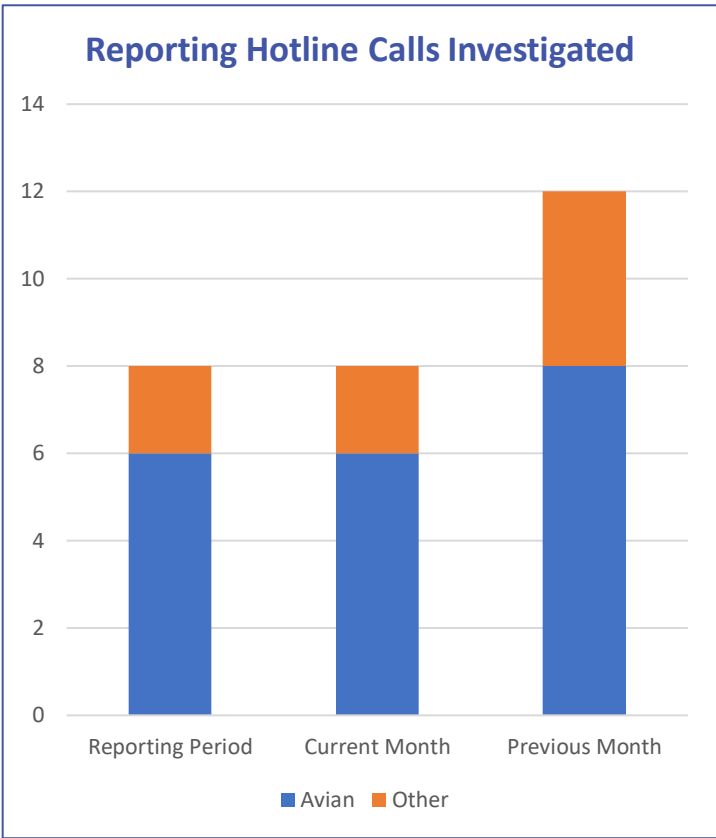
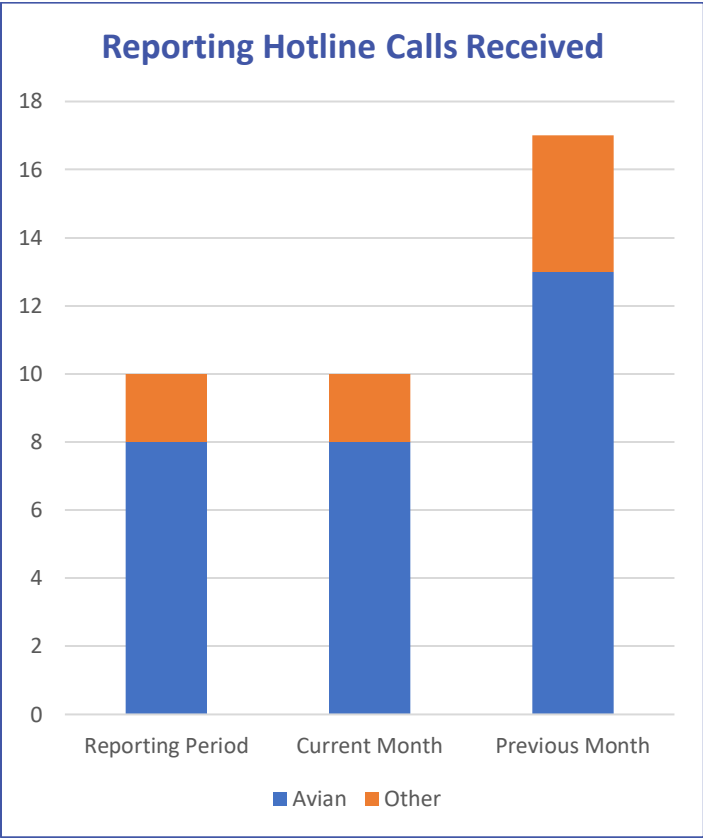
## Map 2
