



Oregon State HPAI Situation Report

CURRENT AS OF DECEMBER 8, 2025

Since November 25, 2025, there has been 0 **additional positive premises in Oregon.**

PREMISES QUARANTINES

Confirmed positive poultry premises are quarantined for a minimum of 120 days on average, although shorter quarantines may be utilized depending on the Cleaning and Disinfection (C&D) methods applicable to the premises. Positive feline premises are not quarantined if the animal is deceased before testing was completed.

ACTIVE REGIONAL QUARANTINES (CONTROL ZONES)

Established for World Organization for Animal Health (WOAH) designated poultry premises. Regional quarantines extend a minimum 10 km around an infected premises with movement restrictions on poultry and poultry products. Regional quarantines involve permitted movements and active surveillance for the designated area.


Map 1
