



2026 JAPANESE BEETLE TRAPPING COMPLIANCE AGREEMENT

1. AUTHORITY AND PURPOSE

Pursuant to ORS 570.305 and ORS 561.240 the Oregon Department of Agriculture ("ODA") enters into this Compliance Agreement ("Agreement") with the nursery identified in this Agreement ("the Nursery") together "the Parties" for Japanese beetle (*Popillia japonica*) trapping and monitoring by the pest consultant identified in this Agreement.

This Agreement describes the trapping and monitoring requirements necessary to certify that nursery stock exported from the Nursery to Importing State is not infested with Japanese beetle. The Nursery agrees to employ the trapping and monitoring protocol described in this Agreement as consistent with the Importing State's quarantine requirements for Japanese beetle.

2. TRAPPING AND MONITORING PROTOCOL

A. Monitoring requirements for Japanese beetle (*Popillia japonica*)

1. The Nursery agrees that to ship nursery stock to the Importing State it must monitor in all locations where nursery stock is grown for the presence of Japanese beetle during the growing season using trap surveys and visual inspection (scouting) as described in this Agreement.

2. To the extent that the Nursery employs the pest consultant identified in this Agreement to conduct the trapping and monitoring activities described in this Agreement, the Nursery agrees to oversee the work described in this Agreement and ensure that the tasks identified in this Agreement are completed consistent with the terms of this Agreement.

3. **Trap Surveys:** The Nursery agrees that trapping and monitoring for Japanese beetle will be accomplished as follows:

a. **Trap type:** Trap surveys will be conducted using traps with dual pheromone lures (flower scent and pheromone) to attract both male and female beetles as recommended by the commercial pest consultant (PC).

b. **Replacement Intervals:** Dual pheromone lures will be replaced midseason at least once.

c. *Timing for Surveys:* Traps must be in placed in nurseries prior to flight period in starting in April and no later than mid-June and continue until the end of September.

d. *Trap Density :*

Nusery Size	Trapping Density	Example
Less than 5 acres	3 traps per nursery	
5 to 30 acres	one trap per each 5 acres above the 5-acre base rate of 3 traps	a 12-acre field would require 4 traps (3 + 1)
30 to 160 acres	1 trap per 10 acres above the 30-acre base rate of 8 traps	a 42-acre site would require 10 traps (8+2)
Greater than 160 acres	8 traps per each 100 acres above the 160-acre base rate of 21 traps	a 175-acre site would require 29 traps (21 + 8)

4. **Maps:** A map indicating the location of each trap in the production field will be kept onsite with the monitoring and service information.

5. **Trap Labeling:** Each trap will be numbered, and that number, along with the placement date, will be recorded on the trap body. The trap number will be recorded on the map in the corresponding location of the trap.

6. **Responsibility for Trap Monitoring:** The Nursery agrees that trap monitoring will be conducted by the commercial pest consultant identified in this Agreement. The Nursery agrees that the pest consultant identified in this Agreement is a qualified commercial pest consultant.

a. A commercial pest consultant is qualified only if the pest consultant can assure the Nursery that any personnel working under the supervision of the pest consultant are qualified to identify Japanese beetle.

b. The Nursery agrees that it will assure that trap monitoring and documentation of the results are true, accurate and complete as described in this Agreement. Growers who are also commercial pest consultants may not monitor traps in their own production fields.

7. **Trap Monitoring Interval:** Traps will be monitored every other week from the time of placement until the traps are removed.

a. *Recording Trap Catches:* Trap catches will be recorded on the trap catch form. Forms must be filled out clearly and completely. The form will be available at the Nursery at the location identified in this Agreement for review when requested by the ODA inspector.

8. *Servicing Records:* Each servicing visit must be recorded on the service/trap catch form.

9. **Electronic Trapping Records:** Electronic records that mirror the data and format of the trap catch form may be used in lieu of the paper document.

10. Response to Trap Catches: The Nursery agrees to notify the Oregon Department of Agriculture within 24 hours of the discovery of any evidence of Japanese beetle.

3. AMMENDMENTS

Amendments to this Agreement must be in writing and signed by the Parties.

4. TERMINATION

The ODA may terminate or suspend this Agreement upon request by the Nursery or according to its sole discretion at any time if ODA determines the Nursery is in non-compliance with this Agreement. The ODA will provide written notice of termination of this Agreement to the

Nursery. If this Agreement is terminated, the Nursery may not export nursery stock to Importing State.

Violators may be subject to fines or civil penalties at the discretion of the Oregon Department of Agriculture.
