## PESTICIDE PRODUCT REGISTRATION INFORMATION

Registration is required by Oregon Revised Statutes — Chapter 634 for each product delivered, distributed, sold, offered or exposed for sale in Oregon. For the purpose of registration, a pesticide product is considered to be a pesticide readily distinguishable from any other pesticide by its content, registration number assigned by the United States Environmental Protection Agency (EPA), brand name, trade name, manufacturer, registrant, use as specified in labeling, or other distinction, but not including net contents or package size.

**Registration Period and Fee:** Pesticide registrations are valid for up to one calendar year and expire on Dec. 31 each year. The *nonrefundable* registration fee is \$400 per product per year or any portion thereof.

<u>U.S. Mailing Address REQUIRED:</u> ODA requires that the registrant or registration agent provide an address <u>in the</u> <u>United States</u> for correspondence purposes.

<u>Product Information:</u> For each product to be registered, please provide the following information on this application form:

- The EPA Reg. No. (except for Section 25(b) exempt products) and full name of the product.
- In the far left column, any of the following designations that apply:
  - » B, if the product is a minimum risk pesticide, exempt from federal registration under FIFRA Section 25(b);
  - » R, if the product is classified by EPA as a Restricted Use Pesticide;
  - » F, if the pesticide product also contains ingredients designed or intended as a source of plant food, to induce or increase crop yields or plant growth, or to produce any physical or chemical change in the soil. Such products also are required to be concurrently registered as a fertilizer, agricultural mineral or amendment, or lime. <u>Special Local Need (SLN or 24c)</u>: All SLN registrations require payment of the registration fee. For each new SLN registration, submit a separate application form and fee, along with a full SLN application package as described in the Oregon Guidelines for SLN Registration, https://oda.direct/SLNRegistration.

<u>Product Labels:</u> For each product to be registered, submit one (1) copy of the labeling that is affixed to and/ or distributed with the product in the marketplace. Supplemental labels, FIFRA Section 2(ee) recommendations, booklets, pamphlets, applicator's manuals, etc., that contain "Directions For Use" are all considered pesticide product labeling and must be submitted with the application. One paper copy of complete product labeling is required.

**EPA Stamped/Accepted Labels REQUIRED:** For each product to be registered, except Section 25(b) products, submit one (1) paper copy of the EPA stamped/accepted label upon which the product labeling is based. Your application cannot be processed without this documentation. If applicable, a copy of federally registered labeling as revised and accepted via notification may substitute for the EPA stamped/accepted label.

Safety Data Sheet (SDS) and Confidential Statement of Formula (CSF): NOT required.

<u>Manufacturing Use Only Products:</u> Technical grade products that are labeled only for formulating end-use pesticide products that are EPA registered. These products are NOT required to be registered in Oregon.

<u>Adjuvants/Surfactants:</u> Oregon does not have a specific registration requirement for pesticide spray adjuvants. However, certain surfactants may be required to be registered as agricultural amendments in Oregon. See ODA's Fertilizer Program for more information on agricultural amendments.

Additional New Registrations and Revised Labels: When an initial registration is approved for a new company, a Pesticide Product Registrations (PPR) license number is established for the company in the ODA licensing database (the license number will appear on the registration certificate sent to the mailing address provided on this application form). Once your company has an active PPR license, revised labels for existing registrations and applications for additional new product registrations must be submitted via the ODA online license/registration system, mylicense. oda.state.or.us. Please do not mail in hard-copy revised labels or additional registration applications using this paper form. ODA also does not accept routine label revisions by email or on CDs or USB memory sticks/flash drives.

**Renewing Registrations:** Registration renewal notification/applications for all registered pesticide products are mailed out in mid-November each year.
