## **Approval of minutes**

## **Interim Director's report**

Interim Director Charpilloz Hanson was asked by Governor Kotek to serve as the ODA Director in October and officially started at the ODA December 1, 2023. Charpilloz Hanson grew up on a family farm in Monitor, Oregon, spent a few years in Eastern Washington working as an agricultural field representative for Green Giant. She joined the ODA in 1996 as the Commodity Commission Program manager and worked her way up in the organization. She spent almost 25 years at ODA, 16 years serving as the Deputy Director. In 2021 she left to serve as the Executive Director at the Oregon Watershed Enhancement Board (OWEB). Her experience at OWEB gave her a strong introduction and integration into the conservation community and there built many relationships that will give her a new perspective in returning to the ODA. Since returning in December, she has met with program directors and managers in the agency to understand where things are going well and where we have opportunities for improvement and thinking about how to use this information to develop our agency requests budget and what our organizational structure looks like today and how to best align ourselves to provide excellent customer service. She advised the board the Governor received resignations from Randi Svaty and Shantae Johnson since the November board meeting. So, we have two partial producer positions to recruit and for the Governor to fill. Individuals interested in serving on the board need to apply through the on-line WorkDay system. Interim Director Charpilloz Hanson has also been meeting with ag organizations to get re-connected since being back on board since December. Goveror Kotek has submitted appointments, including Interim Director Charpilloz Hanson, for Senate confirmation and the hearing is scheduled for February 6.

## Agenda Item 02 – ODA's Budget and Legislative Update

Assistant Director Jonathan Sandau provided a brief update as we head into the 2024 Legislative short session that will start on February 5 and will run through March 10. The ODA does not have any legislative concepts for this session. One piece of legislation we will be tracking and engaging with will be around the canola production in the Willamette Valley. Other topics of interest will be a pilot project for elk and deer damage and funding requests around the grasshopper and Mormon cricket. Looking ahead to the 2025 Legislative session we will have Legislative concepts and working to develop our agency budget request. Deputy Director Henderson talked about looking ahead to the 2025 ODA agency budget request. The ODA will need to look internally and focus on our foundation to rebuild our core programs and infrastructure needs.

## Agenda Item 03 - Industry Panel - Legislative priorities and updates

Industry representatives from 11 organizations shared information and legislative priorities with the Board. Topics ranged from water and land use, specialty seed and canola production in the Willamette Valley, support for food safety programs, investments in meat processing, housing needs, environmental, climate and other natural resource issues.

# Agenda Item 04 - The Use of Easements in Protecting Working Lands Panel

Representatives Dani Madrone with American Farmland Trust, Nellie McAdams with Oregon Agricultural Trust, and Sid Friedman a Yamhill County Farmer gave presentations regarding the use of easements in protecting working lands. They talked about research that has been done around the loss of farmland across the country and here in Oregon. The research provided an analysis of the loss of farmland due to development and the future projections if development patterns continue the same. Between 2001 and 2016, Oregon lost 65,800 acres to urban high-density development and low-density residential development and if these trends continue, then by 2040 another 109,000 acres will be lost. Policy recommendations from this body of work is to encourage smart growth. Oregon's strong land use protections will help reduce the threats of losing farmland. Other policy recommendations include protect agricultural land, support farmland access with succession planning, and advance smart solar siting.

Nellie McAdams, Executive Director of the Oregon Agricultural Trust talked about programs established in Oregon for promoting working lands protection through Working Lands Easements. Her presentation covered what is a conservation easement, how a conservation easement works, and conveying an easement. She also talked about the work done by the Oregon Agricultural Trust, they provide programs to protect agricultural land, technical assistance, education and advocacy.

## Agenda Item 06 – OSU College of Agricultural Sciences – Dean's Update

Dean Simonich shared some updates about the OSU College of Agricultural Sciences. OSU ranks #2 Ag college in the US related to student success and faculty engagement, they had a record of \$114 million in research expenditures last year and anticipate it being higher this year. Enrollment is at 3,300 students, including Ecampus, and continues to grow. All 36 counties in Oregon have Extension and 14 Ag Experiment Stations. She spoke about the statewide public services funding for the 23-25 budget for the Ag Experiment Station research, OSU Extension Service, and the Forest Research Laboratory. She also talked about staffing at the Agricultural Experiment Stations and some of the positions that have been funded.

## Agenda Item 07 - Discussion on the ODA Strategic Plan

Interim Director Charpilloz Hanson began the discussion by clarifying the timeline for the next strategic plan. Governor Kotek rolled out expectations to all agencies in January 2023 that all agencies received. Agencies are required to submit an updated strategic plan by June 1, 2024. The ODA is behind in getting this work underway and we have a lot of work to do to meet that timeline. We will use this updated strategic plan to develop two or three goals to help move the agency forward and to help us build future budget requests. This will be a multi-year, multi-biennium process as we rethink about how we do our work, what and where we do our core work, and the focus for Oregon agriculture moving forward and how to position agriculture for viability and resilience in a changing world.

Assistant Director Jonathan Sandau shared the outline that we are working with to update the strategic plan. Since we are on a shortened timeline, we are going to rely on the 2018 strategic plan to build from, however it is a very different world in 2024 for many factors. We will revisit our mission, vision, and core values for the updated plan. We will engage our staff and external partners to move forward to complete the SWOT and PESTLE analysis and other elements of the plan. We will also incorporate the agency IT strategic plan and the DEIB action plan going forward. We have created an internal team to work on the process and to keep the project on timeline. Discussion followed about board members could assist. A request for an additional board meeting in April was discussed to get feedback from the board on the progress of the draft plan.
