WHAT IS PROPOSED?

The Oregon Department of Agriculture (ODA) is proposing to issue a new registration to the Confined Animal Feeding Operation (CAFO) Water Pollution Control Facility (WPCF) General Permit 01-2015 for an existing, large, tier I, chicken production CAFO to Tuan Tiet dba Molalla Poultry, Inc. The operation's mailing address is 50 H Lane, Navato, CA, 94945 and phone number is (415) 602-8545. The operation is located at 29917 S Sprague Road, Molalla, Oregon in Clackamas County. This facility was previously registered to the #01-2016 National Pollutant Discharge Elimination System (NPDES) General Permit under Master Address #181580 from September 2005 to February 28, 2021.

The CAFO WPCF General Permit #01-2015 regulates the manure, litter, and process waste water generated by CAFOs to ensure that CAFO activities do not harm water quality. You may view the WPCF CAFO General Permit No. 01-2015 online at: <https://oda.direct/WPCFPermit>
