CROWN Act has passed in Oregon!	CROWN ህግ በአሪገን ተላልፏል!
The CROWN Act makes it illegal to discriminate against people who are wearing braids, locs, twists, knots, or protective hairstyles (including a head/hair wrap) in the workplace and public schools, community colleges, and universities.	የ CROWN ህግ ሹሩባ፣ ድሬይድ፣ ጥምዘቶ፣ ቋጠሮዎችን ወይም መከላከያ የፀጉር አሠራር (የራስ/የፀጉር መጠቅለያን ጨምሮ) የሚሰሩ ሰዎች ላይ በስራ ቦታ እና በህዝብ ትምህርት ቤቶች፣ በማህበረሰብ ኮሌጆች እና በዩኒቨርሲቲዎች ላይ አድልዎ ማድረግ ህገወጥ ያደርገዋል።

<ol style="list-style-type: none"> 1. Write down what happened and as many details as you and/or your student can recall. 2. File a complaint at your school. 3. If the complaint is not resolved to your satisfaction, you can file a complaint with the Oregon Department of Education (ODE). ODE requires you to exhaust local processes prior to their involvement. 4. Finally, you may consider filing a complaint with the US Department of Education Office for Civil Rights. 	<ol style="list-style-type: none"> 1. የሆነውን እና እርስዎ እና/ወይም ተማሪዎ የሚያስታውሱትን ያህል ዝርዝሮችን ይጻፉ። 2. በትምህርት ቤትዎ ቅሬታ ያቅርቡ። 3. ቅሬታው በእርስዎ እርካታ ካልተፈታ፣ ለአሪገን የትምህርት መምሪያ (ODE) ቅሬታ ማቅረብ ይችላሉ። ODE ከመሳተፋቸው በፊት የአካባቢ ሂደቶችን እርስዎ እንዲያሟሉ ይፈልጋል። 4. በመጨረሻም፣ ቅሬታዎን ለ US የትምህርት ክፍል ለሲቪል መብቶች ቢሮ ማቅረብ ሊያስቡበት ይችላሉ።
