The FDAB consists of 24 members appointed by the Governor and confirmed by the Senate.

Membership must be from specific categories:

6 public school **administrators** 

6 contract **teachers** 

6 school board members

6 non-affiliated (no occupational affiliation with a school district)

A term is four years. Members may be appointed for two consecutive terms.

Members may continue to serve beyond the end of their second term until replaced through the executive appointments process.

The FDAB is required to hold one regular meeting each year, in October.

At the annual meeting, the FDAB members must select the next Vice Chair.

The Board has also used this meeting as an opportunity to meet fellow board members and staff, hear about appeals resolved during the previous year, and receive informational updates.

### **Bob Sconce, Teacher Representative**

I have been on FDAB since 2012 and have been in education for 33 years in Roseburg. I have been on about 15 different panels through the years. Each appeals case is very different and gives educators an opportunity to have an impartial forum to determine whether their dismissal was fair and lawful. As one of three panel members, you will have the opportunity to conduct formal hearings where evidence is presented, hear testimony from witnesses, and both the District and the educator can argue for their case. The Oregon Department of Justice advises the panel during the case which is very helpful.

## What to Expect as an FDAB Member

When ODE receives an appeal, one of the first things we will do is reach out and request panel volunteers.

Panel composition will depend on the status of the appellant.

- If a teacher files, our panel will consist of members from the teacher, school board member, and non-affiliated categories.
- If an administrator files, our panel will consist of members from the administrator, school board member, and non-affiliated categories.

[Advice for new and newer board members]

It is important for new members to make sure they are volunteering to take on hearings. It shouldn't be up to just a small handful of dedicated board members to take them all. I know there are only certain member types are eligible to make ups panel. But a good selection of eligible members is important.

### Vice-Chair Nomination and Selection

The FDAB has two officer positions: Chair and Vice-Chair. The Vice-Chair is selected at the annual meeting. The Vice-Chair then then succeeds to the Chair and will serve as chair the following year.

The Vice-Chair position rotates in the order of teacher, school board member, non-affiliated, and administrator. For this year, the Board will select the Vice-Chair from the teacher category.

The Vice-Chair must be nominated by a chair-appointed three-member nominating committee made up of Board members from the members not eligible to serve that year. For this year, the nominating committee must be comprised of members from the school board member, non-affiliated, and administrator categories.

The Vice-Chair shall be elected by a simple majority of the members present and voting.

# **Training**

All FDAB members must complete annual training on preventing discrimination and harassment and information security.

Training must be completed by **December 31, 2025.** Training must be completed through Workday.

### Reimbursement and Per Diem for Board Members

All members will be reimbursed for actual and necessary expenses (travel and meals).

Subject to availability of funds in the budget of the board, "qualified members" who are not in full time public service may receive daily per diem compensation.

 "Qualified members" are those who have an adjusted gross income in the previous tax year of less than \$50,000, or less than \$100,000 reported on a joint income tax return
