Upcoming System Downtime

This is a reminder of the upcoming scheduled system downtime for TDS to prepare for the launch of the 2018-2019 Operational Tests for ELA, Math, Science, Social Sciences, and ELPA. ELPA Screener tests and Smarter Interims and Benchmarks for pilot and purchase districts will not be available during this downtime. The TDS downtime is scheduled for Friday, January 4 at 5:00 p.m. PT to Tuesday, January 8 at 6:00 a.m. PT. The full list of Scheduled Downtimes is available on the OSAS Portal.

Oregon Statewide Assessment System Testing Window Opens Tuesday, January 8, 2019 (ELA, Mathematics, Science and Social Sciences)

The Oregon Statewide Assessment System (OSAS) Testing Window opens on **Tuesday, January 8** and will extend through **Friday, June 7**. The OSAS Test Window includes the Oregon ELA and Mathematics Assessments for grades 3rd - 8th and high school, the Oregon Science Assessment for 5th, 8th, and high school, and the optional Oregon Social Sciences Assessment for 5th, 8th, and high school.

 As a reminder, the new 2018-2019 Oregon Science Assessments are aligned to the 2014 Oregon Science Standards. Visit the <u>Science Assessment webpage</u> for more information.

Test Administrators must complete all required training as specified in Section 1.5 of the <u>Test Administration Manual</u> prior to administering these assessments.

Sample and Training tests are available on the <u>OSAS Portal</u> to help students prepare and preview test question types aligned to academic standards.

Upcoming Fall Membership Validation Refreshes

The Fall Membership validation will be refreshed weekly in January starting on **January 10, 2019**. The validation closes on **January 25, 2019**. Please view your data in the <u>Achievement Data Insight</u> Application. The Regional ESD partners will be notifying those districts and institutions that have not yet viewed their data. Validation email notices will go out the week of January 7 to those districts and institutions that have unusual data compared to last school year. Please view and edit your data as early as possible since no changes will be allowed after January 25. Second Period Cumulative ADM Collection Closes January 11

2018-19 Kindergarten Assessment Report Validation Window Open January 3rd

The 2018-19 preliminary Oregon Kindergarten Assessment results are available for districts to review in the Kindergarten Assessment Validation located in the <u>Achievement Data Insight</u> (ADI) application from **Thursday, January 3** through **Friday, January 18, 2019**. This data will be refreshed in the ADI application weekly until the validation window closes on January 18.

REMINDER: Replace ALL Program Type 13 Records in First Period Cumulative ADM REPEAT

Program Type 13 records need to be replaced in First Period Cumulative ADM as soon as college membership information is known. Once these data have been obtained, the district is responsible for requesting that the collection be reopened and updating the record to accurately reflect the additional program information. As a note, a district does not need to know if a student passed a college course to report the information in Cumulative ADM, only how many credits the student attempted.
