GENERAL ANNOUNCEMENTS

Pause Rule Reminder

Please review the pause rules for each test prior to administering tests in Spring 2019. Detailed information on the pause rules can be found in the Oregon Test Administration Manual (TAM) on the OSAS Portal.

Please note: When students are testing on Chromebooks, TAs should make sure that they pause the test before closing the lid of the Chromebook. If the lid is closed before the test pauses, whoever opens the Chromebook next will be able to see the last question that the student was viewing (and any response they entered).

In the event of a technical issue (e.g. power outage or network failure), students will be logged out and the test will automatically be paused. The students will need to log in again upon resuming the test, and the pause rule for that test will apply.

Scheduled Maintenance Downtime Cancelled

The Online System downtime scheduled for Friday, January 11 at 5:00 p.m. PT through Sunday, January 13 at 7:00 p.m. PT has been cancelled as no maintenance is needed at this time. All Online Systems will remain available through the weekend.

PSAT Invoicing

There have been some changes to the overall invoicing process for PSAT (page 47 of the <u>PSAT/NMSQT Coordinators Manual</u>) as well as some changes for those participating in the ODE PSAT contract for sophomores. Here is the new process and timeline:

- **Starting December 3**: Schools can sign in to the test ordering site to review answer sheet counts, complete fee waiver rosters, and make grade-level adjustments.
- January 11: Deadline for identifying fee waiver-eligible students and making grade-level adjustments.
- February April 2019: ODE data match process.
- May 2019: Final invoices will be mailed to schools for all PSAT/NMSQT test takers.

The OSAS Science Assessment will <u>not</u> be available for all students as previously planned and communicated for the January 8, 2019 test window. Our quality assurance reviews have uncovered some concerns with the online delivery platform that must be addressed prior to administration. Our goal is to release a product that meets quality measures for a valid and reliable assessment for all Oregon students.

Assessment Educator Opportunity - Social Sciences Analysis Scoring Guide Pilot

The Oregon Department of Education is recruiting qualified educators to pilot draft versions of an updated Social Sciences Analysis Scoring Guide for the purpose of assessing student assignments, performance assessments, writing responses, reading analysis, etc. for the following grade bands: high school (9 - 12), middle school (6 - 8), elementary (3 - 5).

Educators will be asked to provide feedback on the revised Social Sciences Analysis Scoring Guide. Applicants will also be asked to provide multiple levels of student samples to serve as potential anchor papers for future use to support Oregon educators.

- Recruitment applications will be accepted until **February 8, 2019**. ODE will notify successful applicants of their inclusion in the project, along with information on next steps.

2018-19 Test Records Available and Webinar Training January 16

2018-2019 test records are available for editing in the Student Centered Staging application on the ODE district website beginning January 10, 2019. Accountability Warehouse Extract (AWE), and Secure Assessment Reports 2.0 (SAR) applications will have 2018-19 test records available to download beginning January 17, 2019. PLEASE NOTE that there is a one-day lag for changes to test records in Student Centered Staging (district edits or newly loaded records) to be available in the AWE and SAR applications.

Social Sciences records will typically be available in Student Centered Staging two days after the student completes a test. Scores for students who have completed the English Language Arts (ELA) and Mathematics assessments will be available in the ODE district website applications and in the Online Reporting System (ORS) beginning April 2, 2019. ELA and Math assessments are reported only after a student has completed both parts (Computer Adaptive Test and Performance Task) and all questions have been scored. It takes up to two weeks after a Performance Task is completed for all questions to be scored and for the two parts of the test to be combined and reported.

There will be a Video Training webinar on Wednesday, January 16 at 2 PM. This webinar will focus on management of assessment data in Student Centered Staging (i.e., editing posted records; reviewing and correcting errors; applying administration codes) and accessing the test records in the AWE and SAR applications. If you do not have access to Student Centered Staging, AWE, or SAR applications, please contact your district security administrator.
