# District Assessment Inventory: Deadline is this Friday, January 26

As a reminder, the District Assessment Inventory (DAI) must be completed by **5:00 p.m. January 26, 2024**. District personnel may join ODE staff during DAI "office hours" to ask questions or receive technical assistance regarding the District Assessment Inventory. There is no need to register for DAI office hours; attendees may join or leave at any time using the Zoom links below. DAI office hours are scheduled for the following date:

Friday, January 26, 10-11:00 PT

Districts who do not have a District Assessment Inventory Form need to <u>designate a point of contact</u>. As of 1/22/24, 95% of the districts have a point of contact. Only the District Test Coordinator for a given district should designate a DAI point of contact.

# OSAS Professional Development Opportunity: ELA and Mathematics Summative Test Scoring

The Oregon Department of Education (ODE) is seeking educators interested in participating in the scoring of ELA and Mathematics test items for Oregon Statewide Summative Tests.

 This opportunity to participate in summative test scoring is primarily intended for individuals who would like to deepen their understanding of hand-scored items and the rubrics used to score them.

- As part of ODE's collaboration with Measurement Incorporated (MI), applicants will be signed on as temporary employees with MI and will receive compensation at the standard ODE rate of \$40.94 per hour.
- Applicants will need to apply for either ELA or mathematics scoring.

**NOTE:** There are minimum technical requirements to install and run the scoring platform. For instance, the scoring platform does not run properly on ChromeOS.

The initial training for this project will occur on Monday, March 4, 2024, in Salem, OR. Substitute and travel costs for the March 4 training day will be reimbursed based on ODE guidelines.

Following that training day, qualified raters will then remotely score items during their own off-contract time throughout spring. For additional information, please review the <u>Scoring Recruitment Notice</u>.

ODE will prioritize selection based on educator and regional diversity, active classroom educators and instructional coaches, grade band scoring needs, and a combination of both new and experienced scoring experience.

The deadline for submitting an **application** is **Tuesday, February 13, 2024**, and ODE will notify successful applicants by February 16 along with information on next steps.

#### Alt ELPA Test Window Reminder

The 2023-24 Alternate English Language Proficiency Assessment (Alt ELPA) test window runs from 1/30/24 to 4/12/24. The following elements must be in place to administer the Alt ELPA:

- District IEP teams have identified eligible students and recorded eligibility in the student's IEP (see <u>Alt ELPA Decision Making Resource</u>).
- Test Administrator (TA) has access to the <u>Alt ELPA User Guide</u> and the Alt ELPA TA Directions and Scoring Rubrics Booklets, which are found under the General Resources pulldown in the Test Information Distribution Engine (TIDE).
- TA has the "ELPA Summative" Test Group permission in TIDE.
- Each testing student's English Learner Flag and Alt ELPA Tester Flag are set to Yes in TIDE.

#### **ARAC Recruitment Announcement**

The Oregon Department of Education (ODE) is seeking applicants to fill two vacancies on the Accountability Reporting Advisory Committee (ARAC). The ARAC is a committee defined in rule (i.e., OAR <u>581-002-0090</u>) and provides guidance and recommendations to ODE concerning accountability policies, procedures, and methodologies as well as school and district appeals of accountability data that appear on the At-A-Glance School and District Profiles and Accountability Detail Sheets. The committee consists of individuals from educational institutions representing communities across the state of Oregon.

The ARAC meets quarterly with three virtual meetings and one in-person meeting; however, the ODE occasionally schedules additional meetings when necessary. The length of the virtual meetings is 2 to 4 hours, while the in-person meetings are typically 6 to 8 hours and occur in Salem in August (travel reimbursement is available).

Interested applicants should have knowledge and experience in one or more of the following areas:

- School and district accountability
- Public data reporting for a non-technical audience
- Data collection and validation
- Interpreting assessment or other accountability data
- Research, analysis, and program evaluation

The ODE has a strong commitment to equity and cultural diversity; thus, we encourage individuals with diverse cultural perspectives and experiences to apply. Interested applicants will need to complete a brief <u>online questionnaire</u>.
