ELPA21 Speaking Items - Lenovo Yoga N23 Chromebooks

AIR has received several reports that Lenovo Yoga N23 Chromebooks freeze when an ELPA21 Speaking items are administered on the Chromebook. AIR is working with Google on resolving this issue, and estimates the issue will be resolved in the Chrome 65 OS scheduled for release in mid-March. Until the issue is fixed, please use a different platform for administering the ELPA21 Speaking items. If a student has already begun their ELPA21 test on a Lenovo Yoga N23 Chromebook, their responses will be saved and they should switch to a different device before attempting any Speaking items. This issue only affects Speaking items on Lenovo Yoga N23 Chromebooks. We have not encountered any issues with other brands of Chromebooks.

Oregon Extended Assessment: 1% Participation Cap Reporting Requirement **REPEAT**

In 2015, Congress reauthorized ESEA as the Every Student Succeeds Act (ESSA). With this reauthorization, ESSA **requires that “local educational agencies projected to exceed the 1% cap shall submit information to the State educational agency justifying the need to exceed such cap.”**

Professional Development Opportunity: OAKS (Smarter Balanced) ELA and Math Scoring

ODE is seeking educators interested in participating in the scoring of OAKS (Smarter Balanced) ELA and mathematics test items for the summative assessments. The initial training for this project will occur on **April 20, 2018**, at the Public Service Building in Salem. Following that training day, qualified raters would then commit to scoring items remotely during their own off-contract time during the spring. Applicants would be signed on as temporary employees of ODE and would receive compensation at the standard ODE rate of \$23.91 per hour.

The training is primarily intended for individuals who would like to gain professional development and increased knowledge of OAKS (Smarter Balanced) hand-scored items and the rubrics used to score them. QUESTIONS AND ANSWERS

Answers to Common Questions from the Field

QUESTION: The Science sample tasks (training test in practice test area of the [OAKS Portal](#)) seem to require students to both create the data and analyze the data. How will it be scored if they generate the wrong data, but analyze correctly? Are there ways for the apps to generate the data based on chosen variables?

ANSWER: Yes, some assessment items have simulations that generate data based on the variables chosen by the student. In those items, students are assessed based upon their response to questions about the data they generated. Questions within the item that focus on process, as opposed to content knowledge, are designed to allow the student to demonstrate their ability to analyze data.
