Oregon's State Assessment & Accountability Waiver **Request - Brief Update**

The United States Department of Education (ED) responded to Oregon's strategic waiver request Friday, March 26, 2021. ED did not approve Oregon's request as submitted. However, the last paragraph, similar to the general guidance they offered on February 22, 2021, again points to an opportunity for further discussion about assessment. ODE is engaged in further discussions about what spring 2021 summative assessment expectations will look like in Oregon with ED representatives right now. We expect resolution this week. ODE also plans to submit a separate Accountability Addendum to ascribe to the accountability flexibility that has already been conveyed by ED. The Assessment Team has developed communications to share with education and community partners, but cannot finish writing them nor send them out until a final path forward has been defined. ODE will use typical communication channels to share this information as soon as possible. In the meantime, our recommendation continues to be that districts should prepare for summative assessment administration, being mindful of the fact that our test blueprints have been shortened – resulting in significantly reduced testing times.

The Assessment Team also shared a 3-10-2021 DTC FAQ document that addresses many of the questions we've gotten from our District Test Coordinators related to summative administration that you may find informative. Please contact Dan Farley, Director of Assessment, if you have any questions.

OSAS Science Assessment Multi-State Review Panel Recruitments

The Oregon Department of Education is currently recruiting teachers to participate in several development meetings for the OSAS Science Assessment hosted by Cambium Assessment (CAI). <u>Rubric Validation</u> review is designed to verify assessment scoring is accurate and fair for all students. The role of participants is to make recommendations regarding the scoring of the items and potential adjustments to the rubrics.

<u>Content, Fairness, and Accessibility</u> review is designed to verify standards alignment and analyze items for bias, sensitivity, or accessibility issues.

All meetings will take place <u>virtually</u> and will be scheduled at times to allow participants in different time zones. Each selected panelist will be provided with a registration link to select sessions for which they are available to participate. Participants will be provided a stipend for their time.
