Opt-Out Communication Requirements

Beginning in 2016-17, districts are required to share an Annual Notice about state testing with parents at the start of each school year. As outlined in House Bill 2655, the Oregon Department of Education (ODE) will make this Annual Notice available for districts to download from the ODE webpage by **May 1, 2016**.

A link to the Annual Notice will also be included in the Preliminary 2016-17 Test Administration Manual. The final 2016-17 Test Administration Manual will also contain a link to the 2016-17 version of the 30-Day Notice and the Opt-Out Form.

As a reminder for the current year's test window, districts are required to honor opt-out forms submitted by parents throughout the test window and code students opting-out using Administration Code X in Student Centered Staging. If an opt-out form is submitted *after* a student has already begun testing, have the student stop testing. Should a school accidentally test a student for whom an opt-out form is on file, have the student stop testing and submit a test impropriety report form to ODE. ODE will review such improprieties on a case-by-case basis to determine the appropriate action.

NAEP Update REPEAT

In 2016-2017, the National Assessment of Educational Progress (NAEP) will transition from paper-pencil testing to testing on NAEP-provided tablets with keyboards. In order to understand how to report trend results for the 2017 math and reading assessments, NAEP will conduct a mode comparability study. This means that NAEP will administer both tablet testing sessions and paper-pencil testing sessions in most, but not all, schools. Testing on tablets will require two sequential sessions of up to two hours with about 25 students each and a dedicated space for the school day. The paper-pencil testing will require one session of about 90 minutes with 12 – 20 students in a separate location from the tablet sessions.

In 2017, NAEP will administer math, reading, and writing assessments at grades 4 and 8. There will also be pilot testing at grade 8 for civics, geography, and U.S history. NAEP will not conduct any testing at grade 12. Districts and schools selected for NAEP 2017 will receive notification letters or emails from ODE in May 2016. ELPA21 Testing Window Closes Tuesday, April 19, 2016

The 2015-16 ELPA21 testing window will close as scheduled at the end of the day next **Tuesday**, **April 19**. District staff can use the Online Reporting System to run participation reports for tests that are still in progress, tests not started, and tests completed, in order to know which students may not have finished and submitted their ELPA21 opportunities. All students with an LEP code set to "Y" will show in these reports. EXTENDED ASSESSMENT

U.S. Department of Education: <u>Proposals for Consideration</u> by ESSA Negotiated Rulemaking Committee

The U.S. Department of Education sent proposals today to the <u>committee</u> working on suggested regulations for the <u>Every Student Succeeds Act (ESSA)</u>. Of particular note, the Department proposes language, consistent with the law, that adopts safeguards to ensure that states meaningfully assess students with disabilities and to ensure only <u>students with the most significant cognitive disabilities</u> (click on this link for the complete version of this proposal) are assessed against alternate academic achievement standards. We want to bring this proposal to your attention now, so you are aware of the direction this particular effort is moving —especially in terms of the proposed 1% cap on participation and our respective responsibilities associated in moving towards meeting it.

2016-17 Kindergarten Assessment UPDATE

Kindergarten Assessment Overview:

The 2016-17 Kindergarten Assessment includes three segments:

- 1) **Early Literacy:** an untimed, direct assessment of upper and lowercase English Letter Name and English Letter Sound Recognition. *Officially identified Spanish speaking English Learners **must** also be administered an untimed Spanish Letter Sound Recognition measure.
- 2) **Early Math:** an untimed, direct assessment with sixteen items. *Officially identified Spanish speaking English Learners will be given the bilingual Spanish/English version.
- 3) **Approaches to Learning:** an observational assessment with fifteen items based on the teacher's observation of the student during regular classroom routines and activities.

This year, approximately 3,000 students will also be administered either the timed Legacy Letter Names or the timed Legacy Letter Sounds measure to ensure continuity of longitudinal Kindergarten Assessment data. The preselected schools were contacted earlier this month.

New: Kindergarten Assessment Testing Window:

The 2016-17 Kindergarten Assessment Testing Window will occur between **August 9 - October 20**, **2016**.

KA Training Webinars:

The ODE provided Kindergarten Assessment training is **required** for District Testing Coordinators from all districts supporting kindergarten program in 2016-17. School Test Coordinators and Test Administrators are also welcome to attend these trainings. If you are a District Testing Coordinator, please register to attend one of the following trainings here:

- Wednesday May 25, 2016 from 3:00-4:00
- Wednesday August 17, 2016 from 9:00-10:00

Order Window:

The 2016-17 Kindergarten Assessment **order** window will open **May 23, 2016** and close **June 28, 2016**. Districts will order assessment materials through TIDE based upon anticipated 2016-17 kindergarten enrollment. When ordering, districts will need to specify one of two delivery windows for the materials:

- **August 1-5**, 2016 (to arrive prior to the start of the statewide testing window)
- **August 22-26**, 2016 (to arrive after the start of the statewide testing window).

Test booklets will not be pre-coded by individual student SSID.

Staff FTE and Ethnicity Validations Open Through April 27

The Staff FTE and Staff Ethnicity Validations are currently open in the Achievement Data Insight (ADI) through the end of the day on **Wednesday**, **April 27**, **2016**. These validations include information on staff FTE, race/ethnicity, grade bands served, total/average experience, and percentage of teachers with a graduate degree.

If you have not logged in already (or if you've recently made changes in the Staff Position collection), please log into these validations via the <u>District Site</u> to view your data. Explanations of the various data elements will be in the instructions located at the bottom of your validation's page. More detailed explanations with examples can be found <u>here</u>.

Institutions for Accountability Reporting Validation Open April 21 – May 16

Institution data used in the 15-16 School and District Report Cards will open for review on **Thursday**, **April 21 at 1 PM** and remain open through the end of the day **on Monday**, **May 16**. Please check the data for your institution to ensure accuracy and completeness.

To view the data, log in via the <u>District Site</u>, select Achievement Data Insight (ADI), and then click on the *Institutions for Accountability Reporting* tile to view the associated validation. REMINDER: Post-Graduate Scholars Training on April 20

SB 1537, relating to payment for community college coursework by school districts, adds restrictions to districts' current fifth-year programs, and will require some changes to ADM reporting. ODE invites districts who have fifth-year programs, advanced diploma programs, and/or other options for students to complete college coursework while in high school, or are considering implementing them, to join us on April 20 at 2 pm for a video training on the reporting implications of this new law.
