Legislative Update

Bill	Synopsis	Link
House Bill 2736	Allows school district and public charter school to implement nationally recognized high school assessment in mathematics, science or English if assessment complies with specified criteria.	HB2736
House Bill 3236	Directs Department of Education to implement assessment system that limits number of content-based assessments and criterion-referenced assessments and to encourage school districts to use performance-based assessments.	HB3236
	Allows school districts to determine student's progress toward achieving academic content standards at intervals greater than annually.	
Senate Bill 456	Prohibits State Board of Education, school district or public charter school from requiring student to pass test to demonstrate proficiency in Essential Learning Skills in order to receive diploma. Directs school district or public charter school that did not award person diploma because person did not pass test to demonstrate proficiency in Essential Learning Skills to award diploma to person upon request of person. Declares emergency, effective on passage.	<u>SB456</u>

The Oregon Department of Education requires that **all** District Test Coordinators, School Test Coordinators, and Test Administrators complete required training for the Kindergarten Assessment, using materials developed by the Assessment Team. These materials will be posted after the initial DTC training at the end of May.

If you are a District Test Coordinator, you must <u>register</u> to attend one of the required ODE provided Kindergarten Assessment webinar trainings:

- May 21 at 3:00 PM

- August 14 at 9:00 AM

Kindergarten Assessment Materials

The Kindergarten Assessment materials order window in TIDE will open **May 23** and close **June 18**. Kindergarten Assessment materials may only be placed by district level users.

Orders must be placed for each school in your district that will have kindergarten for the 2019-20 school year. TIDE has been preloaded with materials based upon the number of students who participated in the Kindergarten Assessment in 2018-19. You can also modify the preload numbers, if necessary. You will need one scoresheet for each kindergarten student, one Assessor Booklet and one Student Booklet for every 15 students, and one Approaches to Learning document for every 12 students. Additional overages will be automatically added to your order.

Districts may choose to have the Kindergarten Assessment materials delivered between July 30 - August 2 or August 20 - August 23. Districts must choose a delivery window and click [Save].

This year, the Staff FTE validation includes a new column for Psychologists, and the Library Staff have been divided into one column for Licensed Library staff and another column for Library Support Staff. Data changed in the Staff Position collection up to the end of the day on Monday, April 29 will be refreshed in the validations on **Thursday, May 2 after 1:00 PM**.
