# **Chrome Version 73 Now Supported for Online Testing**

Devices running Chrome version 73 are now supported for secure online testing, with one known issue. In QA testing, the TTS Voice Check occasionally failed to display voice packs. Users can uninstall and reinstall the Secure Browser to resolve this issue. # PSAT 2019 Ordering Information and Important Deadlines

ODE will once again be paying for PSAT/NMSQT tests taken by eligible 10<sup>th</sup> graders. Please note the following important dates:

#### **Testing Dates:**

- Primary test day: Wednesday, October 16
- Saturday test day: October 19
- Alternate test day: Wednesday, October 30

#### Ordering **Deadlines**:

#### June 28:

- Deadline for early ordering. Schools that order by this date will get the PSAT/NMSQT Student Guide by mid-September.
- Deadline to request fee waivers: Requests to increase fee waivers received after this date will be handled on a first-come, first-served basis.

#### September 19:

 Deadline for schools and districts to order, increase, or decrease PSAT/NMSQT test materials. Best Practice: Place your order before you leave for summer, and adjust order at the start of the school year, as needed.

<u>Fee waiver</u>: Any Juniors identified as economically disadvantaged are eligible for a fee waiver for the PSAT/NMSQT. To ensure all eligible students receive their fee waivers, please request fee waivers before the June 28 deadline.

<u>Accommodations</u>: Students with documented disabilities are eligible for accommodations on College Board exams. The deadline for schools to apply for accommodation for the PSAT/NMSQT is **August 20**.

<u>SAT School Day</u>: Schools can order and administer the SAT on Wednesday, October 16 for interested seniors.
