2016-17 Kindergarten Assessment Reminders

KA TRAINING WEBINAR:

If you are a District Testing Coordinator, please register <u>here</u> to attend one of the **required** ODE provided Kindergarten Assessment webinar trainings:

- Wednesday May 25, 2016 from 3:00 p.m. 4:00 p.m. The deadline to register is May 18, 2016.
- Wednesday August 17, 2016 from 9:00 a.m. 10:00 a.m. The deadline to register is August 10, 2016.

ORDER WINDOW:

The 2016-17 Kindergarten Assessment order window will open **May 23, 2016** and close **June 28, 2016**. Districts will order assessment materials through TIDE based upon anticipated 2016-17 kindergarten enrollment. When ordering, districts will need to specify one of two delivery windows for the materials:

- August 1-5, 2016 (to arrive prior to the start of the statewide testing window)
- August 22-26, 2016 (to arrive after the start of the statewide testing window)

Test booklets will not be pre-coded by individual student SSID.

SMARTER BALANCED

Smarter Balanced Scoring Rules

ODE revised the participation rule for the 2015-16 administration of Smarter Balanced English Language Arts and Mathematics assessments: students are considered participants if they respond to at least five CAT items or at least one PT item. Students who do not meet this threshold will be considered non-participants.

ODE has reviewed the scoring rules for Smarter Balanced assessments, and has determined that all students who have responded to at least five CAT items AND at least one PT item will receive a score and a performance level. Students who are participants but did not respond to a sufficient number of items to receive a score will be assigned a performance level of 1, with no score.

Please note that all participants who meet inclusion rules for accountability reports will be included in achievement calculations. Students who meet participation requirements, but not scoring requirements will be counted as not proficient in those calculations. OAKS Extended Assessment 2015-16 Test Records Available

OAKS Extended Assessment records for 12th graders (if submitted in the Extended Assessment data entry application by April 28) will be available on **Friday, May 13** in Student Centered Staging, Accountability Warehouse Extract (AWE), and Secure Assessment Reports 2.0 on the ODE <u>secure district website</u>. District Test Coordinators who wish to edit records for 12th grade students who took an OAKS Extended Assessment in 2015-16 may select the Test Type "Extended Assessments" when searching for records in Student Centered Staging.

OAKS Extended Assessment records for all grades will be posted in Student Centered Staging, AWE, and Secure Assessment Reports on **Friday**, **May 27**.

Be sure to resolve errors before downloading or reviewing records online so that the data is as accurate as possible. Please contact your <u>Regional ESD Partner</u> for more information or for assistance accessing these records.

Class Roster Collection Open May 12 through June 27 REPEAT

The Class Roster Collection will open on **Thursday**, **May 12** and remain open through **11:59 PM on Monday**, **June 27**. The purpose of the Class Roster Collection is to link teachers and students with their instructional courses. Collecting these data makes it possible to identify which students and courses are being taught by each teacher. Institutions required to submit are ESDs, Schools, School Districts, YCEPs, LTCTs, JDEPs, and Skill Centers. The validation for institution data used in the 15-16 School and District Report Cards will close at the end of the day on **Monday, May 16**. Please check the data for your institution to ensure accuracy and completeness.
