# Preliminary 2018-19 Test Administration Manual Now Available

The <u>Preliminary 2018-19 Test Administration Manual</u> is now available. The Preliminary 2018-2019 Test Administration Manual contains all final policies for the 2018 administration of the Kindergarten Assessment. For all other assessments, the preliminary manual describes anticipated policies. ODE will publish the final 2018-19 Test Administration Manual by **October 1, 2018**. Below is a summary of changes compared to the 2017-18 Test Administration Manual:

- 2018-19 Kindergarten Assessment Training and DTC Training dates (Section 1.5)
- 2018-19 opt-out notice dates for the statewide summative assessments in Math and English Language Arts (Section 5.3)
- Added information about the 2018-19 OAKS Science Field Test and new Training Test (Sections 8.1 and 1.7)
- 2018-19 statewide test schedule (Appendix A)
- Updated timeline for exiting students from ELD services (Appendix B)
- Removed second opportunity for OAKS Online Science (Section 8.1)

#### **ELA Standards Review Panel**

This summer, ODE is looking for educators willing to serve on the ELA Standards Review Panel. The Panel will be responsible for reviewing and potentially revising the Oregon ELA CCSS and will meet online several times and face-to-face at least once. Dates will be determined after selected educators provide feedback.

ODE is requesting support from all educators: teachers, specialist, administrators, and high education faculty. Each content area undergoes a standards review process every seven years and before new instructional materials are reviewed for that content area. ODE is recruiting educators to participate in the standards review process beginning this summer.

# **Essential Skills and Local Performance Assessment Anchor Papers**

Oregon Department of Education is seeking teachers who are willing to share student writing samples (grades 3 - 8 and HS). Student writing sample papers will be utilized to create new anchor paper resources aligned to the Official Writing Scoring Guide.

#### What does this mean?

- If you have student writing samples that you would be willing to share, the parent/student must give their permission using this permission form.
- Submit the paper and permission form to ODE (address on permission form).
- Dependent on the quantity and quality of submitted student writing samples, ODE will host a high school anchor paper-scoring institute in July. Resources will be updated and posted on the ODE website during early fall. The writing samples for grades 3 8 will be collected for future paper-scoring institute.
