The study is based on surveys of students, their teachers, and their school administrators completed as part of the 2019 National Assessment of Educational Progress. OSAS Science Assessment Multi-State Data Review Panel Recruitment

The Oregon Department of Education is currently recruiting educators to participate in a multi-state science assessment item data review being held remotely during the week of **August 16-20**, **2021**. The facilitator, Cambium Assessment is scheduling sessions at various times during the week of August 16-20, 2021 in order to allow for participation across multiple states.

Each selected participant will receive a registration link to select sessions for which they are able to participate during that week.

The data review process is designed to utilize statistical flags and item data to identify potentially
problematic content. This flagged content is reviewed by educators to ensure the content is fair and
appropriate. The role of participants is to make recommendations regarding whether this content
should move forward into operational tests or whether adjustments must be made to content to
address the statistical and/or data flag.

<u>Applications</u> are **due by Monday, June 7, 2021**. Panel participants will be compensated for their time. Selected participants will receive a letter of invitation and meeting information from Cambium Assessment.

QUESTIONS AND ANSWERS

ELPA Screener

QUESTION: The ELPA Screener seems to stop earlier for some students than others. Why is that?

ANSWER: This is intended behavior. The English Language Proficiency Assessment (ELPA) Screener has an "early stop rule" that checks early in the test to see if the student can score Proficient in all non-exempt domains.

- If the answer is No, the student cannot score Proficient even if they are administered all remaining items in the Screener, then the test stops.
- If the answer is Yes, the student could possibly score Proficient, then the test gathers more information by administering additional items.
