## **Upcoming Optional ELPA Screener Webinars**

ODE has planned four sessions of an optional informational webinar regarding the English Language Proficiency Assessment Screener. This webinar is designed to accommodate multiple levels of expertise.

The **first hour** of the webinar provides introductory or refresher information on the ELPA Screener. The content in this hour has not changed significantly from previous years.

The **second hour** of the webinar addresses anticipated changes and considerations for 2020-21. Information during this hour presumes familiarity with the ELPA Screener and accompanying systems.

You will need to <u>register for the webinar</u>. The webinar has four identical sessions; choose and attend the time that works best for you.

### ELPA Batch 4 Scores Available on May 19

All remaining scores for students who completed the English Language Proficiency Assessment (ELPA) were posted in Student Centered Staging, Accountability Warehouse Extract (AWE), and Secure Assessment Reports 2.0 (SAR) on the ODE <u>secure district website</u> and also in Online Reports (ORS) on the <u>OSAS Portal</u> on Tuesday, May 19. This is the fourth and final batch of ELPA records for 2020.

District Test Coordinators may download or review records in Student Centered Staging to edit accommodation, modification, or administration codes (see the <u>Test Administration Manual</u>, Appendix C). **Please note** that there is a one-day lag for changes to test records in Student Centered Staging (district edits or newly loaded records) to be available in the Warehouse applications (AWE and SAR).

# DELAYED - Science 2018-2019 Validation Open in Achievement Data Insight May 21 - June 19, 2020 REPEAT

Due to technical difficulties, the Assessment validation window for Science 2018-2019 results is delayed. The validation window will open on **May 21** and remain open through **June 19, 2020**. The validation is accessible through the <u>Achievement Data Insight</u> (ADI) application. Contact your <u>district security administrator</u> if you do not have access to the application, or if you do not see the Science Student Performance tile once you access the application.

The editing window for Science 2018-2019 records will also be extended through **June 19**. Please review your Science 2018-2019 results during this window. **No changes to the Science 2018-2019 data will be allowed after June 19**.
