Smarter Balanced and OAKS Online Test Windows Close June 9

The 2016-17 test window for Smarter Balanced Mathematics and ELA and OAKS Online Science and Social Sciences closes next **Friday, June 9, 2017**. In the final days of the test window, district should use the Test Management Center of the Online Reporting System to identify those students who have not yet tested or still have in-progress tests and prioritize providing these students an opportunity to complete testing. Once the window closes, all partial tests that were not submitted by the student will be pushed through for scoring.

Question & Answer

ANSWERS TO COMMON QUESTIONS FROM THE FIELD

Question: Our first day of our second term was supposed to be January 3, but because of inclement weather days, it ended up being January 9. Should I change the teacher and student start dates in Class Roster to reflect this?

Answer: Yes, if the classes did not start until January 9, the teacher and student start dates for these classes should not be before January 9. However, if you have already submitted your IUID records for these classes, you must first change the course begin dates there. The easiest way to do this is to pull a production download from your IUID collection, change the course begin dates for the courses that were postponed (and possibly the course end dates if the courses were extended), and resubmit this file through a file upload into the IUID collection. The course begin and course end dates will be overwritten with the new dates. Then, adjust your Class Roster teacher/student start and end dates accordingly. Question: I received an error for Class Roster stating that the combination of ClsRmID and ClsPrd must be the same for all instances of a specific ChkDigitInstrctUnitID per collection year. What does this mean?

Answer: This error means that one IUID number was submitted with more than one Class Room ID and/or Class Period. A specific combination of Class Room ID and Class Period should never have more than one IUID associated with it.
