2025-26 DTC Designation Contact Form and Acknowledgement of Service

 - This form is used to maintain ODE's internal contact database and email listservs.
 - The form does not automatically grant access to the TIDE system.
 - The 2025-26 <u>DTC and Information Only Contact Form</u> can be found on the <u>ODE Assessment Administration</u> website under the 'Forms' section.
 - It must be completed and submitted online, with an attached <u>district superintendent signed version of the</u> form, no later than **June 20, 2025**.
- Acknowledgement of Service will be a part of the <u>June 11</u>, <u>2025</u> DTC Webinar. If you are leaving the DTC position or retiring, we would like to acknowledge your service.

TEST ADMINISTRATION

ELA, Math, Science, and SEED Windows Close June 13

The test window for the English Language Arts (ELA), Mathematics, and Science tests, as well as the Student Education Equity development (SEED) Survey, will close at the end of the day 6/13/25.

As a reminder, the test status change for ELPA Summative and Alt ELPA tests is 6/9/25. The test status change deadline for ELA, Math, and Science is 6/20/25. After these deadlines, test records can no longer be changed in the Test Information Distribution Engine (TIDE).

Per <u>ORS 329.078</u>, all school districts must make the Student Educational Equity Development (SEED) Survey available to students in grades 3-11. The survey administration window closes on **June 13, 2025**. District participation levels are publicly reported in the SEED State Report released in the fall. ACCOUNTABILITY & REPORTING

Course Completion and Grades Pilot Collection

ODE will be piloting two new collections for the 2025-26 school year, Graduation Pathway and Course Grade History. These collections will include course grades and credits as well as total credits and GPAs for high school students. File formats are available on the ODE District File Formats page. The data will be used to help evaluate ODE and legislative initiatives to support high school success, and ODE is also planning to use the data to support the <u>Direct Admissions</u> Initiative being developed by the Higher Education Coordinating Commission.

The pilot collection, with data to be collected in Summer 2026, will be used to further develop file formats and business rules for full implementation in the 2026-27 school year. ODE is encouraging districts to participate in the pilot to help us ensure the data collection is flexible enough to meet the needs of school districts, ODE and the Direct Admissions Initiative. Regular Attenders Validation Opens Today

Student Enrollment Validation opens June 5 and first validation checks sent by June 11

The Student Enrollment validation of 2024-25 Third Period Cumulative ADM opens on June 5. The video training is <u>posted</u> on the district website previous training list and <u>linked</u> on each of the three summer validation web pages. Edits to 2024-25 Third Period Cumulative ADM must be completed no later than August

22, 2025. Updates to foster care data will be available in July. All Detail and Summary columns for foster care and ever in foster care will be not visible until after the update.

The first validation check will compare data for Ever English Learner students from 2024-25 against 2023-24. I will send email to those districts that are identified as having unusual Ever an English Learner data changes by the middle of June 9th week. You must make your changes to the Spring ESEA Title III English Learner collection by June 23, 2025. Cumulative Average Daily Membership (ADM) 2024-2025 Reminders

Institutions Database Reminders

The Institutions for Accountability Reporting (IAR) Validation is currently closed but the data will continue to refresh every other week through August for those still making changes this summer. The Validation User Guide and the 2024-25 training video and PowerPoint can be found here. Changes that impact reporting (e.g. contact information including addresses, principal, and superintendents, etc.) must be submitted by the end of the day **September 15**.

Please ensure someone in your district is managing the required documentation for changes that take effect at the end of this school year, including closures of current institutions, obtaining IDs for new institutions, and changing current institutions to reflect the needs for 2025-26. These requests will require an <u>Institution</u> <u>Request Form</u> and often additional supplemental documentation, listed on page 9 of the form.

Class Schedule Collection Closes June 30, 2025

The Class Schedule Collection is currently open and is set to close at the end of the day on **Monday, June 30.** A recording of the web training, and other helpful resources, for this collection are posted on the <u>Class Schedule collections</u> page.

The Class Schedule collection is the source for the Class Size Report. Both the Class Size validation and the Class Schedule audits will open on **July 10, 2025**, at 1:00 PM. A web training will also be held on **July 10, 2025**, at 2:00 PM. A link to the training will be posted on the <u>ODE Training</u> page. The Class Schedule audits will not be different from the previous Class Roster audits.

Ninth Grade On-Track Collection Closes July 7, 2025

The Ninth Grade On-Track collection is currently open and will remain open through the end of the day on **Monday, July 7, 2025**. A recording of the web training, and other helpful resources, for this collection, are posted on the <u>Ninth Grade On-Track collections</u> page. Additionally, the Ninth Grade On-Track validation will open on **Thursday, July 10, 2025**, at 1:00 PM and will remain open through **Friday, August 22, 2025**.

The purpose of the Ninth Grade On-Track collection is to determine how many first-year high school students at each school are "on-track" to graduate within four years. Preliminary Report Processing of 2024-25 Assessment Records

The Assessment Transactional System / ARUA will be **closed** for editing all 2024-25 test records at the following times:

- Friday, May 30 at 5 PM until 9 AM on Tuesday, June 3.
- Friday, June 6 at 5 PM until 9 AM on Tuesday, June 10.

The 2024-25 subjects will also be unavailable in Secure Assessment Reports during these times. After June 10, the 2024-25 subjects will not close again until **August 22**. If you have questions, please contact your <u>Regional</u> ESD Partner.

ELPA Summative and Alt ELPA Batch 4 Scores Available

Scores for students who completed the English Language Proficiency Assessment (ELPA) during April 1-11, 2025 are posted in the Assessment Record Updating Application (ARUA), Accountability Warehouse Extract (AWE), and Secure Assessment Reports 2.0 (SAR) on the ODE <u>secure district website</u> and also in the Centralized Reporting System (CRS) on the <u>OSAS Portal</u> as of Tuesday, June 3. This is the final batch of ELPA Summative records for 2025 and includes records from the Remote administration window (March 4 – April 11).

Test scores for students participating in <u>Honoring Student Proficiency on the HS ELPA Summative</u> are final as of Tuesday, June 3. As a reminder, this means that a high school student's Proficient performance on one or more domains from a prior year will be inserted into this year's test, and the scores for <u>all four non-exempted domains</u> will be recalculated using that Proficient performance. **Please note** that scores appearing in the Centralized Reporting System (accessed through the state portal) are *unofficial* and *will not update with final scores* due to carried domains. Decisions about retaining or exiting English learner status should be made based on finalized score reports found in official ODE data applications such as AWE and Secure Assessment Reports.

District Test Coordinators may download or review records in the ARUA to edit accommodation, modification, or administration codes (see the <u>Test Administration Manual</u>, Appendix C). **Please note** that there is a one-day lag for changes to test records in the Assessment Transactional System (district edits or newly loaded records) to be available in the Warehouse applications (AWE and SAR).

Assessment Record Updating Application (ARUA) Open for Editing 2024-25 Test Records

The Assessment Record Updating Application (ARUA) is currently open for editing 2024-25 test records until **5 PM on Friday, June 6**. The 2024-25 subjects will be available in the ARUA and in Secure Assessment Reports by **9 AM on Tuesday, June 10** and will not close again until **5 PM on August 22, 2025**.

ARUA Components Completed:

- Virtual test records have been created that indicate non-participation of required English Language
 Arts (ELA), Mathematics, and Science summative assessments based on data submitted in the Third
 Period Cumulative ADM collection for enrollment on May 1, 2025. A virtual record is created for the
 student if there is not a valid test in the required content areas as described by the grade of enrollment
 in the ADM collection.
- Accountability fields (such as RCSchlPartic, RCSchlPrfrm and ParticSchlInstID) have been filled on all
 test records that are loaded by Friday, May 30 and indicate which tests are used for accountability
 reporting. These fields are not available in the ARUA download file, but the full set of fields are
 available through the Accountability Warehouse Extract (AWE) Assessment Student Extract or Bulk
 Download option. PLEASE NOTE that there is a one-day lag for changes to test records in the ARUA
 (district edits or newly loaded records) to be available in the Warehouse applications (AWE and Secure
 Assessment Reports).
- Student group information such as race/ethnicity, special education, and other program flags have been filled on all test records that are loaded by Friday, May 30 from Third Period Cumulative ADM for students enrolled on the first school day in May (except the Migrant Education Flag, which is filled from the Oregon Migrant Student Information System, and the Homeless Flag, which is filled from the Summer Homeless collection). - Virtual ELPA test records have been created that indicate non-participation of the required ELPA test
 for English Learner (EL) students, based on data submitted in the Title III: Spring English Learners
 collection as of May 23. A virtual ELPA test record is created for the student if there is not a valid ELPA
 test record for any student identified as eligible for EL services during the current school year. (The EL
 collection will be open for review from June 12 through June 23, 2025.)
- PLEASE NOTE: First-year EL students with a virtual record will <u>not</u> be counted as a <u>non</u>-participant if
 the student has a valid ELPA test record (indicated with data field EngLrnrCd = 'B' on the test record,
 from the AWE download).

ARUA Components Not Yet Completed:

- Virtual ELPA test records have been created that indicate non-participation of the required ELPA test for English Learner (EL) students, based on data submitted in the Title III: Spring English Learners collection as of May 23. A virtual ELPA test record is created for the student if there is not a valid ELPA test record for any student identified as eligible for EL services during the current school year. (The EL collection will be open for review from June 12 through June 23, 2025.)
- **PLEASE NOTE:** First-year EL students with a virtual record will <u>not</u> be counted as a <u>non</u>-participant if the student has a valid ELPA test record (indicated with data field EngLrnrCd = 'B' on the test record, from the AWE download).
- Oregon Extended Assessment records in ELA, Mathematics, and Science (to be loaded by June 27, 2025)

- Science tests partially completed (aka "Partials") (to be loaded by June 27, 2025)
- ELA and Mathematics summative tests completed by June 13 (to be loaded by June 30, 2025)
- ELA and Mathematics tests partially completed (aka "Partials") (to be loaded by July 11, 2025)

If you do not have access to the ARUA, Accountability Warehouse Extract, or Secure Assessment Reports applications, please contact your <u>district security administrator</u>.

Oregon Extended Assessment 2024-25 Test Scores Available June 27, 2025

Oregon Extended English Language Arts (ELA), Extended Mathematics, and Extended Science test records will be available on **Friday, June 27** in the Assessment Record Updating Application (ARUA) and Accountability Warehouse Extract (AWE) on the ODE <u>secure district website</u>. (If you do not have access to these applications, please contact your district security administrator.)

District Test Coordinators who wish to edit records for students who took an OSAS Extended Assessment in 2024-25 may select the Test Type "Extended Assessments" when searching for records in the ARUA. Be sure to resolve errors before downloading or reviewing records online so that the data is as accurate as possible. Please contact your Regional ESD Partner for more information or for assistance accessing these records.

Science Partials and Key Dates for Summer 2025

Science partial test records (any test where the student responded to at least one question or interaction within the first stand-alone item or cluster, but never finished the test) will be available on **Friday, June 27** in the Assessment Record Updating Application (ARUA), Accountability Warehouse Extract (AWE) and Secure Assessment Reports (SAR) applications. (If you do not have access to these applications, please contact your district security administrator.)

Be sure to resolve errors in the ARUA before downloading or reviewing records online so that the data is as accurate as possible. Please contact your <u>Regional ESD Partner</u> for more information or for assistance accessing these records.
