2022-23 District Test Coordinator and Information Only Contact Forms REPEAT

ODE requires that districts annually designate a District Test Coordinator (DTC) using the District Test Coordinator Designation Form. This form is used to maintain ODE's internal contact database and email listserves. (Please note that this form does not automatically grant access to the TIDE system.) DTCs must register with ODE for the 2022-23 school year by June 30, 2022. The 2022-23 District Test Coordinator and Information Only Contact Form is now available on the ODE website. Forms must be completed, signed by the district superintendent, and submitted by June 30, 2022 to Carla Martinez by e-mail or fax (503-378-5156).
