## **Correction to 2024-25 Testing Schedule**

ODE corrected an error in the 2024-25 Oregon Statewide Summative Test Schedule. The OSAS test window for Grade 11 and SEED Survey for Grades 3-11 will open on **February 4, 2025** (not February 5 as previously published). The 2024-25 Testing Schedule and Annual Notice have been updated on ODE's <u>Test Administration</u> webpage. Please contact the <u>ODE Assessment</u> Team with any questions.

## 2024-25 DTC Designation Contact Form REPEAT

Each district needs to submit a 2024-25 District Test Coordinator and Information Only Designation Contact Form by **June 28, 2024**.

- ODE requires that districts annually designate a District Test Coordinator (DTC) using the <u>DTC and Information Only Contact</u> Form.
  - This form is used to maintain ODE's internal contact database and email listservs.
  - The form does not automatically grant access to the TIDE system.
  - The 2024-25 <u>DTC and Information Only Contact Form</u> can be found on the <u>ODE Test Administration website</u> under the 'Forms' section.
  - It must be completed and submitted online, with an attached <u>district superintendent signed version of the</u> <u>form</u>, no later than **June 28, 2024**.

# **SEED Survey Participation REPEAT**

This spring, more students than ever participated in the Student Educational Equity (SEED) Survey. For the first time, all Oregon school districts were required by House Bill 2656 to offer the SEED Survey to students in grades 3 through 11.

This legislative requirement resulted in a tenfold increase in participation compared to last year. Half of students in those grades participated in the 2023-24 SEED Survey. Many thanks to the District Test Coordinators, Principals, School Test Coordinators, and classroom teachers who supported this unique opportunity to systematically collect student voice data from across the state.

What happens next with this data? In August, school districts will be able to access their own SEED data through the Oregon Department of Education's (ODE) Achievement Data Insight application (ADI). A statewide report with all the data will be released by ODE in the fall. Resources for working with SEED Survey data will also be shared.

Why is this survey important? The SEED data will help schools understand how well they are providing an equitable education for all students. This information will be used alongside other data collected by the Oregon Statewide Assessment System (OSAS) to identify areas for improvement.

# **ELPA Screener Summer Availability**

Both the Future K and Grade K English Language Proficiency Assessment (ELPA) Screener will go offline **July 19, 2024** for the yearly testing system rollover. The Future K ELPA Screener will reopen **August 1, 2024**; the Grade K Screener will open on **January 14, 2025** (alongside the Alt ELPA and the ELPA Summative).

Student demographic information will not be updated in the Test Information Distribution Engine (TIDE) from **June 29** to **July 19, 2024**, so districts administering the ELPA Screener during those dates should use Temporary IDs only. Demographic data will begin loading in TIDE **August 20, 2024**.

# Class Roster Audits and Class Size Validation for 2023-24 open July 11, 2024

Class Roster audits open at 1 pm on **July 11**. There are no changes to the audits this year. The <u>2023-24 Class</u> Roster Audit Manual is posted on the Class Roster page on the district website.

The Class Size validation also opens after 1 pm on **July 11**. The <u>2023-24 Class Size Technical Manual</u> is posted on the Class Size validation page on the district website and the Class Size Report page.

<u>Training</u> for both the audits and the validation will take place **July 11 at 2 p.m.** The slides will be posted in early July before the live Zoom training. The training will be recorded. # 2023-24 At-A-Glance Narrative Data Collection Opens July 11 – September 20, 2024

The At-A-Glance Narrative Data Collection opens on **July 11** and will close on **September 20, 2024**. The At-A-Glance Narrative Data Collection is located within the <u>Achievement Data Insight (ADI)</u> application. ### **English Language Arts and Mathematics Partials**

English Language Arts (ELA) and Mathematics partial test records (any test where the student completed at least one item, but never finished the test) will be available on **Friday, July 12** in the Assessment Record Updating Application (ARUA) and Accountability Warehouse Extract (AWE) application. If you do not have access to these applications, please contact your <u>District Security Administrator</u>.

#### Partials with no scores

Test records where the student completed at least five computer-adaptive (CAT) items OR one
performance task (PT) item, but <u>not both</u>, are valid tests with no scores and performance level 1 for
the total test and all reported claims.

#### Partials with scores

 Test records where the student completed at least five CAT items AND one PT item have scores and performance levels for the total test, and if all CAT items were answered, scores and performance levels for the reported claims.

# Science Partials and Key Dates for Summer 2024

Science partial test records (any test where the student responded to at least one question or interaction within the first stand-alone item or cluster, but never finished the test) will be available on **Friday, June 28** in the Assessment Record Updating Application (ARUA), Accountability Warehouse Extract (AWE) and Secure Assessment Reports (SAR) applications. (If you do not have access to these applications, please contact your District Security Administrator.)

Be sure to resolve errors in the ARUA before downloading or reviewing records online so that the data is as accurate as possible. Please contact your <u>Regional ESD Partner</u> for more information or for assistance accessing these records.

#### Oregon Extended Assessment 2023-24 Test Scores Available June 28, 2024

Oregon Extended English Language Arts (ELA), Extended Mathematics, and Extended Science test records will be available on **Friday, June 28** in the Assessment Record Updating Application (ARUA) and Accountability Warehouse Extract (AWE) on the ODE <u>secure district website</u>. (If you do not have access to these applications, please contact your <u>District Security Administrator</u>.)

District Test Coordinators who wish to edit records for students who took an OSAS Extended Assessment in 2023-24 may select the Test Type "Extended Assessments" when searching for records in the ARUA. Be sure to resolve errors before downloading or reviewing records online so that the data is as accurate as possible. # Ninth Grade On-Track Collection Closes July 5 REPEAT
