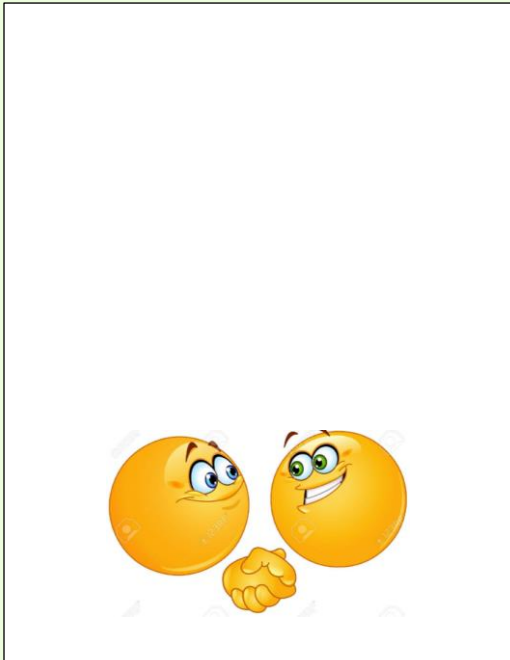

Kindergarten Assessment Data Collection Training (Strongly recommended for all districts supporting Kindergarten Programs) **REPEAT**

The Kindergarten Assessment data collection window is **August 11 - October 31, 2016**. There are three Kindergarten Assessment collections: Approaches to Learning, Early Literacy, and Early Mathematics. ODE will host two optional data collection webinar trainings provided below:

- **Tuesday, August 23, 2016:** 2:00 PM-4:00 PM PDT
- **Thursday, September 22, 2016:** 2:00 PM -4:00 PM PDT

Staff only need to attend one of the training times. The same PowerPoint will be shared during both webinars training sessions. To attend one of the training times, click the following link:

The trainings will be broken-down into two parts:

1. First half of the training will focus on changes from last year, and new field requirements;
2. Second half of the training will be a deeper look including information on how to submit/review your data and accessing student roster reports.

Staff who are responsible for submitting the Kindergarten Assessment data to ODE are strongly encouraged to attend the training so they can ask the data owner questions during the training.

On Thursday, June 23, the Oregon State Board of Education adopted the following cut scores for demonstrating proficiency in the Essential Skills. These cut scores (also known as achievement standards) can be applied for students who have test scores on the revised PSAT, revised SAT, or Aspire assessments, even if the test scores come from test administrations that occurred prior to June 23.

- **PSAT:**
 - Math: 24.5
- **SAT:**
 - Math: 24.5
 - Reading: 24
 - Writing: 27
- **Aspire:**
 - Math: 431
 - Reading: 425

ODE has also developed a [table](#) showing the status of all assessment options and a [description](#) of the process for evaluating new or revised assessment options along with information about the timeline for other assessments undergoing revisions.

OAKS Online Partial and Key Dates for Summer 2016

OAKS Online Science and Social Sciences partial test records (any test where the student completed one or more questions, but never finished the test) are currently available in the Student Centered Staging, Accountability Warehouse Extract (AWE) and Secure Assessment Reports 2.0 applications. If you do not have access to these applications, please contact your [district security administrator](#).

Records where the student completed 1-4 questions have a Test Attempted flag of 'P' and no scores or performance levels. Records where the student completed 5 or more questions have a Test Attempted flag of 'Y', a Rescore flag of 'Y' and an adjusted total score (no strand scores) and performance levels.

Be sure to resolve errors in Student Centered Staging before downloading or reviewing records online so that the data is as accurate as possible. Please contact your [Regional ESD Partner](#) for more information or for assistance accessing these records.

Schedule of Collections and Validations (that impact Report Cards and other accountability reports):

- July 11 -** Annual Cumulative ADM collection closes (changes may be made by district request only through August 19)
- July 7 - Sept 30 -** Report Validation Window for Class Size
- July 14 - Sept 23 -** Collection Window for Report Card Narrative (Supplemental)
- August 19 -** Last day for changes to Student Centered Staging (to be reflected in Public release of Report Card Details and State Test Results)
- August 19 -** Last day for changes to Third Period Cumulative ADM (to be reflected in Public release of Report Card Details and State Test Results)
- August 19 -** Report Card Validations close for Not Chronically Absent, Student Enrollment, Student Attendance, English Language Arts Student Performance, Mathematics Student Performance, Science Student Performance

Class Roster Audit and Review Period

The Class Roster collection's Audit and Review window will open **Thursday, July 7** (at 1 PM) and will close **Friday, July 15 at 11:59 PM**. Every district should log into their Class Roster collection to view their audits, which can be found under Error Management, Review Audits. Districts may also use this window to submit data that they were unable to submit during the reporting window.
