Now Available: Unique Screening Guidance for 2020-21

Due to complications arising from COVID-19, some students who were scheduled to complete English Language Proficiency testing in spring of 2020 did not begin, or only partially completed, the English Language Proficiency Assessment (ELPA) Summative. In order to determine these students' need for language services in school year 2020-21, districts will administer the ELPA Screener (a process ODE is calling "unique screening"). ODE has completed guidance on Unique Screening in 2020-21.

This guidance explains the unique screening process in detail, and is intended to be used alongside previously published guidance on <u>Administering the ELPA Screener with Physical Distancing</u>. Please note that the short treatment of this guidance in the ELPA Screener Informational Webinar (found on the <u>Assessment Training Materials page</u>) contains outdated information; the recording will be replaced after the delivery of the August edition of the webinar.

As a brief reminder, here are ELPA-related windows in the 2020-21 school year (all dates inclusive):

Unique screening	8/4/20 through 11/20/20	Link to guidance

ELPA Summative	1/5/21 through 4/9/21	Anticipated; may change due to COVID-related factors.

2020-2021 Science Interim Assessments Repeat

Science Interim Assessments are now available for purchase for the 2020-2021 school year. Purchases can be made by district, or for specific schools within a district. The Science Interim Assessments are aligned to the NGSS Science content standards and include the full array of accessibility resources used for the OSAS Science Assessment, including TTS, Spanish translation, and Braille. For more information about the Science Interim Assessments, please refer to the Science Interim Assessments Information Sheet.

The Science Interim Assessments are offered at \$4.95 per enrolled students in grades 5, 8, and 11. Students in grades 3 through high school are permitted to utilize the assessment bank as deemed appropriate by the school and educator.
