Oregon Statewide Assessments: Braille Code Support

With the transition from English Braille American Edition (EBAE) to Unified English Braille (UEB) code in teaching blind/visually impaired students started in 2016, 2019-20 will be the last year EBAE will be supported for all applicable Oregon statewide assessments (cf. Oregon Accessibility Manual for specific information).

OSAS Accessibility Support: Speech-to-Text Update

Per a request from a district last year, ODE has temporarily approved the use of a "Transcribe" accessibility support for the 2019-20 Oregon Statewide Assessment System (OSAS) (i.e., Math, ELA, and Science). This non-embedded Designated Support is to be used in conjunction with Speech-to-Text (STT) and/or Word Prediction. The purpose of this support is to move the student's written words from a device that will use STT and/or Word Prediction software to a device that is running the OSAS Secure Browser.

Other than this temporarily approved option, students needing STT have the option to use Windows or Mac machines running permissive mode and using the third party STT software the district has available. In the meantime, our OSAS platform vendor American Institutes for Research (AIR) continues work on a full-fledged Speech-to-Text (STT) solution with the intent of rolling it out in time for the 2020-21 school year. As part of this effort, AIR will be doing a pilot of the in-house STT solution this year (2019-20). More information about the pilot will be shared with the field as it becomes available.
