2019-20 English Language Proficiency Assessment **Screener Training Materials Available**

Oregon Accessibility Manual

The Oregon Department of Education (ODE) strives to provide every student with a positive and productive assessment experience, generating results that are a fair and accurate estimate of each student's achievement. In the process of developing its next-generation assessments to measure students' knowledge and skills as they progress toward college and career readiness, ODE recognizes that the validity of assessment results depends on each and every student having appropriate accessibility supports (formerly "accommodations") when needed based on the constructs being measured by the particular statewide assessment. Oregon Extended Assessment: "1.0 Percent Participation Cap Reporting Requirements Update" Webinar

Per a review by the US Department of Education and, consequently, a required plan for addressing Oregon's exceeding the 1.0 percent participation requirement per ESSA, ODE has revised the reporting requirements to more effectively support districts that exceed this threshold for any/all content areas. Specifically, districts will utilize the updated electronic platform to: 1) Assure ODE of their familiarity and use of the Oregon Extended Assessment Guidance, 2) Provide evidence supporting the justification(s) for exceeding the 1.0 percent participation requirement, and 3) Submit a plan for addressing any/all justifications for exceeding this requirement. More detailed information on the changes in "what" and "how" districts will report to ODE will be provided via the "Oregon 1.0 Percent Cap: Reporting Requirements Update" webinar on September 17, 2019.

Ninth Grade On-Track Validation Closes Friday, August 9

The Ninth Grade On-Track Validation is currently open in the <u>Achievement Data Insight</u> and will close at **11:59 PM on August 9**. Please log into this validation to verify your students who are and are not on track to graduate. Training for this validation was part of the Achievement Data Insight training conducted on June 5, and a recording is posted on the <u>Video Training</u> page. Data will continue to be refreshed in the validation throughout the summer, but the validation tile will be located under the "Closed" tab after August 9. Student Enrollment Validation

Data submitters and reviewers: Look for validation email notices for Student Enrollment by Wednesday during the week of July 29, 2019. These notices highlight unusual data compared to last year. Notices to check Ever English Learner student data were already sent out in June to give submitters a chance to edit the Title III collection before it closed on June 24, 2019. Whether you get an email notice or not, please review your student enrollment validation data. The Student Enrollment validation is based on Third Period Cumulative ADM data. The last day to make edits to Third Period Cumulative ADM is **August 23, 2019. No changes will be allowed after that date.**
