#### **Student Enrollment Validation**

Data submitters and reviewers: Look for validation email notices for Student Enrollment the week of July 30, 2018. These notices highlight unusual data compared to last year. Whether you get an email notice or not, please review your Limited English Proficiency (LEP) and Ever LEP student numbers as LEP is a new field this year, and the calculation for Ever LEP counts has changed. This validation is based on Third Period cumulative ADM data. The last day to make edits to Third Period ADM is **August 24, 2018.
