## **Request Braille Files for OSAS Interim Tests**

While braille files remain available on request within the testing interface for both summative and interim tests, ODE now allows test administrators to request braille files for interim test items for embossing prior to test administration. Braille files can be requested for all interim tests in ELA, Math, and Science. Files will be delivered in all available forms of braille via the Secure File Center; users requesting files must have an active account in TIDE. As a reminder, all embossed braille materials must be collected and securely destroyed at the end of each assessment session to maintain test security. ## **August Materials Published to Test Administration Page**

The Test Administration Manual (TAM), Oregon Accessibility Manual (OAM), and SEED Survey Manual have been published and are available on the Test Administration page. The TAM, OAM, and SEED Survey Manual are considered preliminary until approved by the State Board of Education. They will be updated to their final versions on or prior to 10/1/25.

- The <u>Preliminary Test Administration Manual</u> outlines policies and procedures for the Oregon statewide assessments. Changes from previous versions are listed in Section 1.2.
- The <u>Preliminary Oregon Accessibility Manual</u> outlines policies and requirements governing the provision of accessibility supports for students participating in Oregon's Statewide Assessments. Changes from previous versions are listed in the Change Log.
- The <u>Preliminary SEED Survey Administration Manual</u> contains necessary guidance (per OAR 581-022-2100) and technical information to administer the Student Educational Equity Development (SEED) Survey.

## **August 2026 ELPA Informational Webinar Scheduled**

The August 2026 English Language Proficiency Assessment (ELPA) Informational Webinar has been scheduled and is available for registration. This optional webinar provides an overview of updates regarding ELPA testing and related policy. The webinar will be held over Zoom. Register at the following links:

Although much of the information in this webinar is repeated from the May session, there will be new information on Early Proficient, Honoring Student Proficiency renewal, and switching to the ELPA Summative fixed form.

Information shared in this webinar will also be made available asynchronously. Webinar slides and a compiled Q&A will be posted after the second session. The morning and afternoon sessions are identical; there is no need to register for both. ## **ELPA Updates for 2025-26**

There are several important updates and changes for ELPA testing in 2025-26.

- Beginning in 2025-26, the in-person ELPA Summative will be delivered as a *fixed form* instead of the previous semi-adaptive format.
  - Students will complete each non-exempt domain individually (Reading, Writing, Listening, and Speaking). For students with no domain exemptions, this means logging into four separate domain tests.
  - All students in the same grade band will receive the same set of items.
  - Testing time will be equivalent or perhaps slightly shorter than the previous in-person ELPA Summative.

- Students may skip items on the fixed form ELPA Summative. Unanswered items are scored as incorrect.
- There are no other changes to items, presentation, difficulty, scoring, or any other feature of the test.
- There are no changes to the remote ELPA Summative, which was already delivered via the fixed form.
- A new scoring category is available for Grade K-12 ELPA Summative tests in 2025-26: Early Proficient. Early Proficient materials are in development and will include:
  - District-facing Early Proficient guidance. Districts must review this guidance when published, as district action will be required for students who score Early Proficient on the 2025-26 ELPA Summative.
  - o Family-facing materials. They will be published in English and Spanish.
  - The existing ELPA Summative <u>Proficiency Descriptors</u>, found in the Assessment Pulldown, will also be updated with a definition of Early Proficient.
  - Guidance and other supporting materials will be added to the Guidance accordion on the <u>ELP</u> Assessment page.
- ODE's Honoring Student Proficiency policy was renewed through the 2028-29 school year.
  - Honoring Student Proficiency on the ELPA Summative and Alt ELPA has been updated with new information about Grades 6-8, the Alt ELPA, "freezing" carried performance, and interactions with Early Proficient.

## Class Size Validation Checks for the Week of August 4-8

There were a couple problems this summer with staff updates and class identifiers maintenance in Class Schedule. These two issues have been resolved, and data editing is ongoing. There are still 22 schools missing from the Class Schedule collection. Please contact your <u>Regional ESD partners</u> as soon as possible to address any errors or difficulties you may have had.

Class Size Validation checks will go out this week. All types of core subject and self-contained classes were evaluated for changes in medians and numbers of reported class types. These checks identify unusual data and large changes in data contrasted to the 2023-24 school year. Also, institutions were identified that have missing students in cumulative Third Period ADM, or did not offer specific academic subjects under Division 22.

## School and District Accountability Appeals Due to ODE on August 13, 2025

The Oregon Department of Education will <u>consider appeals</u> regarding accountability data displayed on the 2024-25 Accountability Detail sheets and the At-A-Glance School and District Profiles. On behalf of their respective schools, districts may submit the following to ODE:

- A written request from the school district superintendent or the superintendent's designee, received at ODE by **5:00 PM PDT on August 13, 2025**.
- Appeals must be accompanied by appropriate documentation.

Districts that wish to submit an appeal must return the appropriate materials to <u>Elyse Bean</u>, Research Analyst by email. Please use the secure file transfer to submit student level data (if applicable). # **REMINDER: Validations Closing on August 22, 2025**

The following validations will close on **August 22**, and **no changes will be allowed beyond that date**. Make sure that you review your data thoroughly before that deadline, and contact the data owner using the "Ask A Question" feature if you have questions or need to make corrections. All of these validations are located in the <u>Achievement Data Insight</u> (ADI) Application.

- Student Enrollment
- Regular Attenders
- English Language Arts Student Performance
- Mathematics Student Performance

- Science Next Gen Student Performance
- Ninth Grade On-Track
- On Track to English Language Proficiency (ELP)
- Student Mobility

These validations contain data that will appear on the school and district At-A-Glance Profiles, as well as other accountability reports. If you do not have access to ADI, or cannot see one of the tiles you should be reviewing, contact your <u>district security administrator</u> immediately. Permissions to these validations must be granted separately for each validation. Training on the use of the ADI, and on several of the validations, is available on the <u>ODE District Training</u> page.

#### ARUA 2024-25 and Third Period Cumulative ADM to Close for Final Report Processing

The Assessment Record Updating Application (ARUA) will be closed for editing 2024-25 test records on **August 22 at 5 PM** for final report processing. The Third Period Cumulative ADM collection will **close on August 22 at 11:59 PM** for final accountability report processing. **No changes will be allowed after this date.** 

Assessment 2024-25 records will re-open by **9 AM on Tuesday, August 26**. All subjects will be read-only (i.e., downloadable but not editable) at that time.

# **QUESTIONS AND ANSWERS**

# **ESSA Test Administration Monitoring**

Per U.S. Department of Education requirements, ODE has implemented a five-year desk monitoring cycle for district test administration. The **ESSA Test Administration Monitoring** process began in Spring 2025. Districts and ESDs in **Year 2** of the monitoring cycle should review the <u>ESSA Test Administration Monitoring – Resources</u> Guide for detailed information on the process and upcoming deadlines.

**Reminder for Year 1 Districts and ESDs:** The self-assessment submission deadline for Year 1 was **June 30, 2025**. Districts/ESDs that have not submitted their self-assessment will be contacted by the ODE Assessment Team.

#### **Understanding the Monitoring Cycle**

**QUESTION:** What is the monitoring cycle?

**ANSWER:** Districts participate in ESSA Test Administration Monitoring once every five years. The first five-year monitoring cycle began in Spring 2025 (**Year 1**). For the 2025–26 school year, ODE will work with **Year 2** districts and ESDs.

Cycle Timeline: Year 2: Spring 2026, Year 3: Spring 2027, Year 4: Spring 2028, Year 5: Spring 2029.

**QUESTION:** What if I'm unsure which year my district falls into?

**ANSWER:** Refer to the *ESSA Test Administration Monitoring Rotation of Districts* document to determine your assigned year in the current cycle.
