

# Kindergarten Assessment Assurance Form

Prior to administering the Kindergarten Assessment or handling confidential student responses staff (including volunteers) must have a signed **Kindergarten Assessment Assurance form** (available <a href="here">here</a>) on file at the District Office, valid for the current school year (see *Appendix D: Assurance of Test Security Forms*). Kindergarten Assessment TAs and **other authorized staff handling confidential Kindergarten Assessment student responses** must renew this form annually. All TAs must also satisfy the test administration training and reading requirements described in Section 1.5 Training Requirements. **Any individual who will be interacting with students during administration of the Kindergarten Assessment is considered a TA**. # **Updated English Letter Sound Recognition Instructions**

The English instructions for the English Letter Sound Recognition on page 5 of the Operational Assessor Booklet and Operational + Legacy Sounds Assessor Booklet and page 7 of the Operational + Legacy Letter Names Assessor Booklet have been updated (this edit did not affect the Spanish version of these instructions).

The 7th bullet under the English Directions in the English Letter Sound Recognition English Instructions currently says:

"Now, we are going to look at more letter sounds. Here are some to practice. When I say begin, I want you to point to each letter pair and tell me the sound the letter pair makes. You will continue until we have reached the last letter pair. Begin."

This bullet will need to be replaced with:

Answers to Common Questions from the Field



**Question:** Why are my staff members not showing up in Web Submission for Class Roster?

**Answer:** The Web Submission application will only pull up staff members associated with your school district for the current school year (16-17). You must first update your staff members for whom you are trying to submit in the USID collection before submitting new class roster records through Web Maintenance.

**Question:** Do I need to mail out a paper copy of the opt-out notice and form to every parent in my district?

**Answer:** Districts may communicate with parents using existing communication protocols, including but not limited to fall registration materials, parent conferences, electronic media, or letters home (Section 5.3 of the TAM).
