# **TEST ADMINISTRATION**

## **Preliminary TAM Published**

The Preliminary 2023-24 Test Administration Manual (TAM) is now available on the <u>Test Administration page</u>, in the Administration Manuals accordion. The Test Administration Manual outlines policies and procedures for the Oregon statewide assessments.

See Section 1.3 Summary of Changes for updates from the 2022-23 TAM. Two changes of particular note:

- Information has been added regarding reporting testing improprieties and irregularities related to optouts or parent requests for exemption.
- Appendix B has been added as a required reading for all Test Administrators (TAs).
  - The ELPA Screener Administration Manual has also been updated to reflect this new training requirement.

## **ACCOUNTABILITY & REPORTING**

## **Class Size Validation Checks Delayed**

Due to illness, the Class Size validation checks were delayed from the week of August 14, but were conducted instead on August 21, 2023. All types of core subject and self-contained classes were evaluated for changes in medians and numbers of reported class types. These checks identify unusual data and large changes in data contrasted to the 2021-22 school year. Schools were also identified that were missing from Class Roster, had missing students in Class Roster, or did not offer specific academic subjects under Division 22.
