PSAT Bulk Registration

The Oregon Department of Education will allow districts to participate in Bulk registration for their sophomore PSAT/NMSQT® test takers again this year. Bulk registration will allow districts to submit student information online and schools will receive printed pre-ID labels for student's answer sheets free of charge. The benefits of Bulk Registration include:

- Improves data accuracy: Data submitted by districts is more accurate than student provided data, making results more useful.
- Reduces billing discrepancies: Contract billing is based on grade level. Using district-submitted data eliminates the issues caused by students bubbling in the wrong grade or not bubbling in any grade.
- Saves time on test day: Bulk registration reduces the time students spend filling out registration information on test day, allowing them to focus on the test.

Last week, DTCs received an email from The College Board with their district's Bulk registration access code and the instructions. Bulk registration opened on Monday, August 13 and closes approximately three weeks before your test date (details below). Deadlines for submitting data files and details about bulk registration can be found on The College Board's <u>Bulk Registration webpage</u>.

QUESTIONS AND ANSWERS

Answers to Common Questions from the Field

QUESTION: In the <u>August 23 A&A Update</u>, you said that students who take the ELPA screener still need to take the ELPA summative. My understanding was that only students identified as eligible for ELD services take the ELPA summative.

ANSWER: That is correct. The intent of the August 23 FAQ was to clarify that the ELPA screener does not replace the ELPA summative; they are different tests which, while complementary, serve different purposes. A more full explanation follows:

- A student who takes the ELPA screener and receives one of the "Not Proficient" determinations (Emerging,
 Progressing, or Proficiency Not Determined) qualifies for ELD services and therefore will take the next required
 ELPA summative (see Table 20 in the <u>Test Administration Manual</u> for the next required ELPA summative based
 on student enrollment date). An ELPA screener score cannot substitute for an ELPA summative score, even if
 the two tests take place within the same school year.
- A student who takes the ELPA screener and receives a Proficient determination does not qualify for ELD services and therefore will not take the ELPA summative.
