Oregon Accessibility Manual Update

As shared during the District Testing Coordinators Meeting on August 26, 2020, the Oregon Accessibility Manual (OAM) will be made available on **Tuesday, September 15, 2020**. The OAM will be posted on the <u>Oregon Test Administration webpage</u> under the Administration Manual expandable tab.

Overview of the Interim Assessment System Webinar Session

Understanding a Balanced Assessment System Webinar Session (Final Virtual Event)

In Session 1 - Understanding a Balanced Assessment System: Participants will build assessment literacy to improve instructional practices by connecting formative assessment practices, interim assessments, and summative assessments to continually improve access and outcomes for each and every learner in their care.

Oregon Statewide Interim Assessment System "Go Live" Date

The Oregon Statewide Interim Assessment System is going "live" on **Tuesday, September, 15, 2020**. The interim assessments allow teachers to check student progress throughout the year, so educators can use the results to inform instruction and help students meet the challenge of college-and career-ready standards. ODE has provided statewide access to the ELA and mathematics interim assessments. ODE has also developed a Science Interim Assessment System, which is available for districts and schools to purchase. For additional information about the science interims, please refer to the <u>Science Interim Assessments Information Sheet</u>. The interim assessments are available in grades 3–8 and high school and can be administered at multiple points throughout the school year.

As a reminder, educators must complete the required training requirements before a District Testing Coordinator or School Testing Coordinator providing access to the system, please refer to the training requirements included in <u>Training Module 8 – Interims: Remote Administration and Test Security</u>.

2020-2021 Science Interim Assessments REPEAT

Science Interim Assessments are now available for purchase for the 2020-2021 school year. Purchases can be made by district, or for specific schools within a district. The Science Interim Assessments are aligned to the NGSS Science content standards and include the full array of accessibility resources used for the OSAS Science Assessment, including TTS, Spanish translation, and Braille. For more information about the Science Interim Assessments, please refer to the Science Interim Assessments Information Sheet.

The Science Interim Assessments are offered at \$4.95 per enrolled students in grades 5, 8, and 11. Students in grades 3 through high school are permitted to utilize the assessment bank as deemed appropriate by the school and educator.

ACCOUNTABILITY & REPORTING

2019-20 Adapted At-A-Glance School and District Profiles

On <u>May 28, 2020 ODE announced</u> the suspension of the 2019-20 At-A-Glance School and District Profiles and the suspension of the At-A-Glance validation in the Achievement Data Insight (ADI) application. Because the <u>suspension of statewide assessments and ODE data collections</u> impacted the data available for publication, the At-A-Glance profiles had to be *adapted* in order to meet state and federal reporting requirements that were not covered under the <u>waiver</u> from the U.S. Department of Education.

The goal of the Adapted At-A-Glance Profiles remains the same as the profiles published in previous years, which is to provide an overview of a school or district to parents and families in a format that is easy to read and understand.

Schools and districts will have the ability to preview their Adapted At-A-Glance profiles prior to the public release by requesting an embargoed copy. Unlike in previous years, previews will not be available in the ADI application. We anticipate previews of the Adapted At-A-Glance Profiles to be available upon request at the end of September.

The Adapted At-A-Glance School and District Profiles are scheduled for publication in both English and Spanish on **October 15, 2020**. The published Adapted At-A-Glance profiles will be available to <u>download on ODE's website</u>.
