The suspension of the assessment of essential skills is in effect through 2023-24, which means that it does still apply to this school year. The current recommendation that will now go before the State Board in October, given Chair Martinez-Zapata's decision that she explained at Thursday (9/21) morning's State Board of Education meeting, is to extend the suspension of the policy through 2027-28.

QUESTIONS AND ANSWERS

Answers to Common Questions from the Field

QUESTION: I have conflicting information between Cumulative ADM and the Abbreviated Day collection. For the Abbreviated Day collection, I was told that sites have been asked to mark students absent from periods if the class reduction is by parent election rather than through a district-determined abbreviated school day. Do we follow this same guidance for Cumulative ADM reporting, and mark the student absent from classes the student does not attend due to their abbreviated day and include them when determining FTE or hours of instruction?

ANSWER: Cumulative ADM reporting only includes instructional time that the student receives, and we use actual instructional time to determine FTE. We may not report time that the student does not receive instruction and would not include attendance for classes the student is not enrolled in and attending.
