DTC Training Modules Updated for 2022-23

The District Test Coordinator (DTC) training modules for Oregon's summative assessments have been updated for 2021-22. The following modules are now available in both audio and no-audio versions:

Final 2022-23 TAM Now Available

The final version of the 2022-23 <u>Test Administration Manual</u> (TAM) has been posted to the Test Administration page, under the Administration Manuals pulldown.

The Test Administration Manual outlines training requirements for district personnel, such as District Test Coordinators (DTCs) and Test Administrators (TAs). It also details policies and procedures for the Oregon statewide assessments, to ensure both test reliability and validity from classroom to classroom, teacher to teacher, school to school, and district to district.

The final TAM corrects minor discrepancies in the Preliminary TAM. There are no major changes.

Alt ELPA Introductory Communication Disseminated

A new test called Oregon's Alternate English Language Proficiency Assessment (Alt ELPA) will become available in the Oregon Statewide Assessment System (OSAS) in 2022-23. The Alt ELPA is an English language proficiency assessment designed for students with English learner status who also experience the most significant cognitive disabilities. The Alt ELPA was developed by the Collaborative for the Alternate Assessment of English Language Proficiency (CAAELP), and tailored for Oregon's assessment context.

In introductory communication with more details about the Alt ELPA has been distributed to districts via assessment, English learner, and special education listservs. New resources have also been published to the Alt ELPA section of the <u>ELP Assessment page</u> and the <u>Resources section</u> of the state portal.

OSAS Remote Testing Resources Available REPEAT

ODE will continue providing a remote testing option for the OSAS Summative Tests, OSAS Interim Tests, and SEED Survey. ODE has updated communication and training resources on the <u>ODE Test Administration</u> web page under the "Remote Testing Resources" menu. Educators administering assessments or surveys remotely must complete the following training requirements:

- Module 10: Remote Testing (located on the Training Materials page);
- The Remote Test Administration Certification Course (located on the <u>OSAS Portal: Test Administrators</u> page).

As a reminder, schools must receive permission from families prior to student participation in any remote testing session. Once a school has received permission for remote testing, the TIDE Student Settings for that individual must be updated to allow for remote participation.
