Answers to Common Questions from the Field

Test Improprieties

QUESTION: I want to reopen or reset a test that a student was unable to complete. On the new <u>test</u> <u>impropriety report form</u>, which of the two core requirements do I choose?

ANSWER: Since the impropriety or irregularity is related to test completion, choose the first core requirement: "Students complete the correct test in a supervised, secure, and distraction-free test environment."
