Deadline for 2020-21 DTC Training Modules and Survey is November 2 REPEAT

As a reminder, to satisfy the 2020-21 District Test Coordinator (DTC) training requirements, all DTCs must:

- Review the 2020-21 Summative Assessment Training Modules by November 2;
- Complete the 2020-21 Training Quiz by November 2; and
- Participate in one of the ODE-facilitated Webinar sessions scheduled for November 3 - 5.

If you have not already watched the training modules and submitted your survey response, please make time to complete these requirements by **November 2**. ODE will use the survey responses to track who has watched the required modules and to develop the curriculum for the ODE-facilitated Webinar sessions. "Tools for Teachers" Grand Opening REPEAT

The new instructional resource called <u>Tools for Teachers</u>, developed in partnership with Smarter Balanced, is now available to help educators support their students during this challenging back-to-school season. Tools for Teachers features standards-aligned lessons and activities created by educators to enhance their instruction. These high-quality resources are flexible and accessible to meet the needs of diverse learners, whether they are learning in-person or remotely.

Tools for Teachers, along with companion Smarter Balanced resources like the <u>Back to School</u> <u>Assessment Playbook</u> and the <u>Remote Teaching and Learning website</u>, provide guidance on using the <u>formative assessment process</u> to support instruction and accelerate learning this coming school year.

Tools for Teachers was developed with a commitment to accessibility and is available <u>free</u> to educators throughout Oregon. The website provides access to a variety of resources, including:

- Lessons and activities with built-in accessibility strategies that can help teachers support students' varying needs and preferences.
- Meaningful descriptions of grade-level expectations to help teachers monitor progress.
- Formative strategies to help teachers identify where students are in their learning, where they are going, and how they will get there.

All K-12 educators with an active account in TIDE can access Tools for Teachers through a <u>direct link</u> or through the <u>OSAS Portal</u>. Test Administrators automatically have access to Tools for Teachers; for users who will not be TAs, or users new to a district, ODE has created a new "Tools for Teachers" user role (TFT_SC) through which users can access Tools for Teachers. This user role can be activated in TIDE by the DTC or STC.

INTERIM ASSESSMENTS

2020-2021 Interim Assessments Now Available REPEAT

The statewide test window for the Oregon Interim Assessment System in ELA and Math is now open for the 2020-2021 school year. Schools and districts may administer these assessments to students in-person or remotely. To assist with questions regarding test administration, viewing scores and results, hand-scoring

items, and Tools for Teachers refer to the <u>Interim Assessment Guide for Administration of ELA & Mathematics</u>, which is available on the <u>OSAS Portal</u>.

Additional instructions on how to administer these assessments remotely are available in the <u>Quick Guide to Administering Interim Assessments Remotely</u> available on the <u>OSAS Portal</u>.

The Assessment Viewing Application (AVA) is available to provide educators with access to the actual Interim Assessments for administrative or instructional purposes before students are tested. Please refer to the <u>Assessment Viewing Application User Guide</u> for detailed information on AVA. The Centralized Reporting System (CRS) is also open to view results from the Interim Assessments. Please refer to the <u>Centralized Reporting System User Guide</u> for detailed information on the reporting system.

As a reminder, <u>Training Module 8 - Interims: Remote Administration and Test Security</u>, posted by the ODE Assessment team, is **required for all educators to complete** before their District Test Coordinator (DTC) can provide user role access to the Interim Assessment System.

- If an educator has completed the 2019-20 TA requirements, they will only need to provide evidence they have completed this Module 8 Interim Assessment Remote Administration and Test Security.
- If an educator did not have a TA user account from the 2019-20 instructional year or if the educator
 has transitioned to a new district which is different from last year. They must complete the reading
 requirements in Table 5 of the Test Administration Manual and in addition to completing Module 8,
 they must also complete training Modules 2, 3, and 4 available on the ODE Test Administration,
 Assessment Training Materials Page.

2020-2021 Science Interim Assessments REPEAT

Science Interim Assessments are now available for purchase for the 2020-2021 school year. Purchases can be made by district, or for specific schools within a district. The Science Interim Assessments are aligned to the NGSS Science content standards and include the full array of accessibility resources used for the OSAS Science Assessment, including TTS, Spanish translation, and Braille. For more information about the Science Interim Assessments, please refer to the Science Interim Assessments Information Sheet.

The Science Interim Assessments are offered at \$4.95 per enrolled students in grades 5, 8, and 11. Students in grades 3 through high school are permitted to utilize the assessment bank as deemed appropriate by the school and educator.

Graduation and Dropout Validations Open Today

The NCES Dropout and Graduation Rate Validation and the Four-Year and Five-Year Cohort Graduation Rate Validations open today, October 22, in the <u>Achievement Data Insight</u> (ADI) application and will remain open until **December 11**. Please be sure to complete your First Period Cumulative ADM data submission and your Exit Adjustment review before reviewing your data in these validations. The new matches to GED certificates have been applied to the data in these validations. Due to technical difficulties, the Foster Care student group will not be displayed correctly and some of the older matched GED data are missing during this first generation. All other groups are correct. For resources, please view the two <u>trainings</u> (Oct. 1 and Oct. 15) that cover the graduation/dropout process and review the <u>Cohort</u> and <u>NCES Dropout & Exit Adjustment</u> manuals.
