TEST ADMINISTRATION

2022-2023 Sample Tests Now Available

Sample tests for Mathematics, English Language Arts (ELA), ELPA, and Alt ELPA are now available. Sample tests can be accessed using a supported web browser or the OSAS Secure Browser. The 2022-2023 OSAS Online <u>Test Administrator User Guide</u> provides further information about using the TA Interface.

These sample tests provide an opportunity for Oregon teachers and students to familiarize themselves with the navigation and functionality of the online tests, as well as with the embedded accessibility supports described in the <u>Oregon Accessibility Manual</u>. All test administrators, including test administrators who have used the TA Interface in previous years, should practice setting up a test session using the updated TA Training Site prior to administering an operational test.

As a reminder, the Alt ELPA Sample Test is intended to be navigated with the help of TA-facing instructions (found on the <u>OSAS Portal</u>).

30-Day Notice and Opt-Out Forms for 2022-23

According to ORS 329.479, "At least 30 days prior to the administration of statewide summative assessments, a school district or public charter school must send to parents and adult students a notice about the statewide summative assessments." This statute also requires ODE to "establish a form to excuse a student from taking a statewide summative assessment." Based on the 2022-23 testing windows, districts and public charter schools must distribute the 30-Day Notice on or before December 11, 2022.

ODE provides both fillable and non-fillable PDFs of a combined 30-Day Notice and Opt-Out Form in English, Spanish, and ten additional languages on the <u>Test Administration page</u>. The English-language forms are currently posted and the translated forms will be available within the next two weeks. Graduation and Dropout Validations Open Today

The NCES Dropout and Graduation Rate Validation and the Four-Year and Five-Year Cohort Graduation Rate Validations open today, October 27, in the Achievement Data Insight (ADI) application and will remain open until December 9. Please be sure to complete your First Period Cumulative ADM data submission and your Exit Adjustment review before reviewing your data in these validations. The new matches to GED certificates have not yet been applied to the data in these validations. For resources, please view the two trainings (Oct. 6 and Oct. 26) that cover the graduation/dropout process and review the Cohort and NCES Dropout & Exit Adjustment manuals.
