# ESSA "1% Participation Requirement"

With the reauthorization of ESEA as the Every Student Succeeds Act (ESSA) the requirement changed for the alternate assessment based on alternate academic achievement standards (e.g., Oregon's Extended Assessment): ESSA places a 1% cap on participation in the assessment. It states that, for each subject, the total number of students assessed using the alternate assessment is not to exceed 1 percent of the total number of all students in the State who are assessed in each subject. Additionally, it states that local educational agencies exceeding the 1% cap shall submit information to the State educational agency justifying the need to exceed such cap." ### **ODE Science Local Performance Assessment Revision Committee Recruitment**

# **QUESTIONS AND ANSWERS**

# **Answers to Common Questions from the Field**

**QUESTION:** When creating a Temporary ID for the ELPA screener, I accidentally entered the wrong name or birthdate. What should I do?

**ANSWER:** The most important function for a Temporary ID is to correctly associate a student with his/her unique screener result. No other data sources pull from this ID. Demographic information errors in the Temporary ID do not carry over to other pools of data.

Temporary IDs cannot be edited, so if there is any risk of failure to associate the correct Temporary ID/screener result with the correct student, a new Temporary ID should be created. Otherwise,

- If there is **no such risk** and **testing has not yet begun**: you may create a new Temporary ID for the same student with correct demographic information if desired.
- If there is no such risk and testing has begun: do nothing. Do not stop testing and do not create a new Temporary ID.
