## ELPA21 2015-16 Data and Student Reports Update

As previously announced, the 2015-16 ELPA21 student score results are expected to be available for districts in late November, after the assessment data has been reviewed and confirmed. ODE is conducting an intense review of the ELPA21 student data and hopes to have the information posted by **November 30, 2016**. In addition, ODE will be providing both bilingual and English-only individual student reports in a mail-merge format. ## 2016-17 Kindergarten Assessment Review Window

The 2016-17 Kindergarten Assessment Collections: Approaches To Learning, Early Literacy, and Early Mathematics closed on Monday, October 31.

The Kindergarten Assessment Collections Review Window is **open from Monday**, **November 14 to Monday**, **December 5**, **2016**. Please log into each collection during this time and view the audits by going to the Error Management menu/Review Audits. During the review window, districts have the opportunity to view and correct identified audit items checked against First Period Cumulative ADM that include: Missing assessment records, gender, race/ethnicity, date of birth, merged SSIDs, students in First Period Cumulative ADM with no records in KA collections/submissions, and

students with records in the Kindergarten Assessment collections but are not in First Period Cumulative ADM. If you have other changes/additions to make to the collections, you may make them during this time.

The Audit Manual for the Kindergarten assessment collections can be found on the <u>Kindergarten Assessment District Resource page</u>.

Same as last year, the preliminary school and district rosters and aggregate reports will be available for districts to review in the Achievement Data Insight Application from **January 5 to January 20, 2017.** ODE will refresh the preliminary data *on an as needed basis.*
