Support Update - iOS 11.1 Added; iOS 11.0 Blocked

AIR and ODE have announced support for iOS version 11.1 for secure testing. Due to a security concern, AIR has blocked iOS version 11.0, and it will not be supported. Districts should take steps to ensure their iPads are not updated to iOS 11.0 and that any devices that are upgraded are running iOS version 11.1. AIR has posted an updated Operating System Support Plan that reflects support for iOS 11.1 and that iOS 11.0 is not supported.

KINDERGARTEN ASSESSMENT

2017-18 Kindergarten Assessment Audit Review Window

The 2017-18 Kindergarten Assessment Collections: Approaches to Learning, Early Literacy, and Early Mathematics closed on Monday, October 30.

The Kindergarten Assessment Collections Audit Review Window is open from Monday, November 20 through Monday, December 4, 2017. Please log into each collection during this time and view the audits by going to the Error Management menu/Review Audits. During the review window, districts have the opportunity to view and correct identified audit items checked against First Period Cumulative ADM that include: Missing assessment records, gender, race/ethnicity, date of birth, merged SSIDs, students in First Period Cumulative ADM with no records in Kindergarten Assessment collections/submissions, and students with records in the KA collections but are not in First Period Cumulative ADM. If you have other changes/additions to make to the collections, you may make them during this time.

Same as last year, the preliminary school and district rosters and aggregate reports will be available for districts to review in the Achievement Data Insight (ADI) Application from **January 4 through January 19, 2018**. ODE will refresh the preliminary data on an as needed basis.

SMARTER BALANCED

Oregon Smarter Balanced ELA Assessment 2017-2018 Update

The Oregon Department of Education will implement a streamlined Smarter Balanced test blueprint at grades 3-8 and high school beginning this school year (2017-18). The purpose of streamlining the ELA/Literacy test blueprint is to reduce the testing time while retaining comparable validity and reliability of the full test. Testing times are projected to reduce by approximately 1 hour for ELA in all grades. The <u>Oregon Smarter Balanced ELA Blueprint</u> provides complete information about the number of items and depth of knowledge for each assessed target.

QUESTIONS AND ANSWERS

Answers to Common Questions from the Field

QUESTION: Is there flexibility in accommodations? For example, if "read-aloud" is designated in the IEP, but the student never gets read-aloud in the classroom but gets "text-to-speech," can the school make the change without having to go back and change the IEP?

ANSWER: While similar in purpose, the differences in effectively providing these supports (i.e., "human" read-aloud and the TTS)—so as to support the student's ability in demonstrating what they know and can do—would require they be delineated specifically in the IEP; that is, the IEP would need to be revised to more accurately reflect the support the student needs. In addition, it is presumed that any/all supports listed on Statewide Assessment page of the IEP for this student include those a student uses in the classroom.
