## Graduation and Dropout Validations Close Friday, December 8

The NCES Dropout and Graduation Rate Validation and the Four and Five Year Cohort Graduation Rate Validations in the <u>Achievement Data Insight (ADI)</u> application close **Friday**, **December 8**.

#### Reminder of the December Refresh and Foster Care Student Counts

The only refresh scheduled for the Fall Membership validation in December will happen next week. The membership extract will occur December 9, 2023. The validation refresh begins on **December 11, 2023**, and preliminary data will be displayed in Achievement Data Insight (ADI) no later than **December 14, 2023**.
