ODE Strategic Assessment and Accountability Waiver

The Oregon Department of Education (ODE) plans to request a temporary pause to specific statewide assessment and accountability expectations present in the Every Student Succeeds Act [ESSA, Sec. 1111(b)] from the United States Department of Education. This request is necessary because the assessment conditions required for summative assessment to meet its purposes have been substantially impacted by COVID-19 pandemic, social and political unrest, and other factors. ODE plans to ask for a temporary pause in English Language Arts, Mathematics, and Science summative testing for 2020-21. ODE remains committed to summative assessment when the conditions that support appropriate uses are in place and plans to implement statewide assessments in 2021-22, or when conditions next allow. National Assessment of Educational Progress (NAEP) Postponed to 2021-2022

On November 25, 2020, the National Center for Education Statistics (NCES) announced plans to postpone the NAEP 2021 mathematics and reading assessments to the 2021–2022 school year. A statement explaining the decision is posted on the NCES website.

However, NCES believes that exploring educational experiences within the context of COVID-19 could be valuable to states and districts for the 2020–2021 school year. NCES developed questions related to the impact of the COVID-19 pandemic for the NAEP school and teacher questionnaires. NCES is considering administering the NAEP questionnaires to teachers and administrators this year. A decision will be announced as soon as it is made.

Graduation and Dropout Validations Close Friday

The NCES Dropout and Graduation Rate Validation and the Four and Five Year Cohort Graduation Rate Validations in the <u>Achievement Data Insight</u> (ADI) application close **Friday, December 11**. If you have not already reviewed your validations, or if you have since made changes to your ADM collection affecting these data, please review these validations before they close. For resources, please view the two <u>trainings</u> (Oct. 1 and Oct. 15) that cover the graduation/dropout process and review the Cohort and Exit Adjustment/NCES Dropout manuals. All appeals are due by **5 PM on December 18**. These data will be refreshed next Thursday, December 17 after 1 PM, and the final refresh will occur on **December 31, 2020**.
