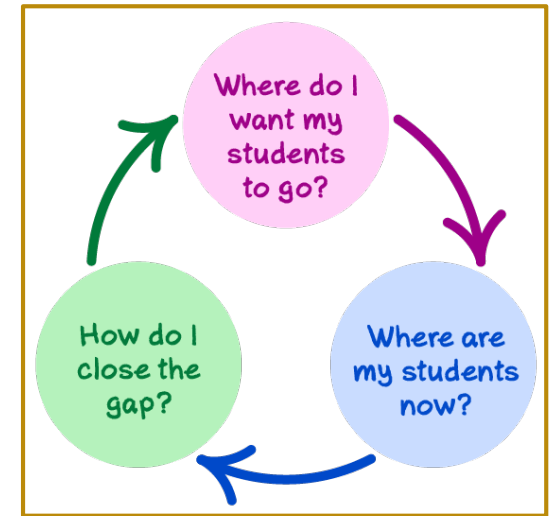
Updates and Reminders

- Remote ELPA Window and in-person ELPA Summative window will overlap in 2023-24
- ODE does not provide score reports to individuals - this must be done by district or school staff
- 2023-24 test window discussion still in progress

Formative Assessment Professional Development Opportunity: Middle School ELA Educators (a)

ODE is seeking school-based teams of middle school ELA teachers to participate in ongoing collaborative learning and coaching around the formative assessment practices.

- The ideal team would be **three or more middle school ELA teachers** with support from their administrator.
 - Teams will participate in 10 hours of asynchronous online professional learning distributed over the course of the year (summer 2023 through summer 2024).
 - Each teacher who completes all project activities will receive a \$1000 stipend (paid in portions across the year).



Formative Assessment Professional Development Opportunity: Middle School ELA Educators (b)

Teaching Practice Cycles: During the school year, teachers will engage in four teaching practice cycles (2-3 hours each) where they learn about specific formative assessment practices, participate in a learning community, and record videos of their own teaching practice using what they have learned.

Feedback: During summer 2024, teachers will engage in peer observations of videos recorded during the school year, provide feedback to peers on their formative assessment practices, and receive feedback from peers to reflect on their own practice prior to the next school year.

HECC Updated Placement Policy

[Higher Education Coordinating Commission](#) (HECC) recently released an [updated placement policy](#)

- Timeline: class of 2023 and beyond.
- Grade level: “high school” rather than grade 11
- Placement testing: students are exempt from developmental education courses, but not necessarily from placement testing (not a change - updated language makes it more clear).
- Purpose: integrate the high school results plus continued course taking into the institutions’ multiple measures for college course placement process.
- Commitment to policy: each student who scores 3 or 4 in high school and then continues to take respective courses (English Language Arts or Math).

Test Impropriety Updates

ODE has been monitoring trends in testing improprieties and would like to remind educators of the following:

- TAs should verify the appropriate student support settings are updated and accurate in TIDE before test administration.
- TAs should remind students that they are selecting the **pause button** rather than “***end test***” to avoid accidental submissions of the ELA PT.

ODE is requesting that DTCs send out a friendly reminder within their districts as we work towards the close of the testing window.

Question 1: What happens to the multiple SSIDs in TIDE when an SSID is merged in the ODE SSID System?

ODE communicates the merge to Cambium in the daily file.

- Cambium moves any tests that were started/completed on the **end-dated SSID** to the **current SSID**, and
- Cambium inactivates the end-dated SSID in the OSAS Portal so it is no longer accessible.

The test settings from the end-dated SSID are not copied to the current SSID. Ensure that all test settings are entered on the current SSID in TIDE before testing.

Contact your Regional ESD Partner if you find the end-dated SSID is still available in TIDE.

Question 2a: **As I run reports for completions, where can I enter Opt outs?** How do we remove a student from our reports that is no longer a student with us?

- **You may use TIDE to block a student from taking a test, but this does not flag the student as opting out.**
 - Enter assessment administration codes (including opt outs) via the ARUA- Assessment Record Updating Application/ Assessment Test Staging/ Assessment Transactional System located in the Central login on the ODE District Data site. See TAM Appendix C or contact your Regional ESD Partner for more information.

Question 2b: As I run reports for completions, where can I enter Opt outs? **How do we remove a student from our reports that is no longer a student with us?**

- **The ODE SSID System is the source of SSID data. Students are only removed from the list in the OSAS Portal when another Oregon school claims the SSID in the ODE SSID System.**
 - If a student has multiple SSIDs, your Regional ESD Partner can get them merged.
- **Schools are accountable for testing students who are reported in Third period ADM as enrolled on the first weekday in May.**
 - This year, that is May 1, 2023
